The Board of County Commissioners of Van Wert County, Ohio, met in regular session in the office of said Board on the 1<sup>st</sup> day of February, 2022, with the following members present: Mr. Thad Lichtensteiger and Mr. Todd D. Wolfrum.

Mr. Lichtensteiger moved the adoption of the following **RESOLUTION**:

**WHEREAS**, the passage of Senate Bill (S.B.) 52 has provided the opportunity for county commissioners and township trustees to participate in the siting of solar projects in their communities; and

**WHEREAS**, the Wild Grains Solar Project planned for Hoaglin Township will be impacted by this new legislation, and it will require a commissioner or designee to serve as an Ad Hoc Voting Member of the Ohio Power Siting Board; therefore be it

**RESOLVED**, that this Board of Van Wert County Commissioners does hereby appoint Commissioner Todd D. Wolfrum to the Ohio Power Siting Board as an Ad Hoc Voting Member in regard to the Wild Grains Solar Project planned for Hoaglin Township.
