Dear Ms. White and Ms. McNeal:

This letter serves as The East Ohio Gas Company d/b/a Dominion Energy Ohio's (DEO) pre-application notification letter in the above-referenced matter. In accordance with Ohio Administrative Code 4906-6-03(A), DEO provides the following information:

Project Description: This project involves the replacement of approximately 1,335 feet of an existing 10-inch diameter pipeline (MAOP 187 psi) with 16-inch fusion bond epoxy ("FBE") and powercrete epoxy coated steel pipeline, and replacement of approximately 580 feet of non-jurisdictional 6-inch diameter bare steel pipeline (MAOP 60 psi) with 8-inch diameter medium density plastic pipeline. The existing pipeline (both jurisdictional and non-jurisdictional) will be abandoned in place.

The project is located within the City of Ashtabula, Ashtabula County, Ohio. The pipeline will be installed in public road right-of-way and existing easements on W. 30th street, between the existing DEO metering and regulating station and 105 feet north of the intersection of W. 30th street and Humphrey Avenue. Existing public roadways, DEO right-of-way and DEO's temporary construction easements will provide the required equipment access.

Anticipated Project Schedule: Construction is anticipated to begin in April 2022 and placed in service by the end of Q3 2022.

Request for Expedited Treatment: DEO requests expedited treatment for this application, and will submit payment of \$2,000.00 in accordance with OAC 4906-6-04(A)(2).
