- 1) The March 1, 2022 DR response states that there was a mix-up in the PJM Supplemental ID number for this case. Have you presented this project at any PJM Subregional RTEP Committee – Western meetings? Please provide the date(s) of the meetings where this project was discussed.

RESPONSE: Yes, ATSI presented the need for this Project at the PJM Subregional RTEP Committee—Western meeting on July 16, 2021, and the solution at the August 16, 2021 meeting.¹

¹ Since then, cancellation of a different project resulted in PJM's finding a violation that ATSI must address; ATSI will therefore re-present the solution at a subsequent PJM Subregional RTEP Committee—Western meeting.
