Honorable Examiners Greta See and Jacqueline St. John:

Glenwood Energy of Oxford Inc. (Glenwood) and the Staff of the Public Utilities
Commission of Ohio (Staff) filed a Stipulation in the above-referenced cases on January
13, 2022 that provided the following language:

Glenwood should file an application to adjust its UEX rider rate within 30
days of the Commission's order in this proceeding, or in the alternative, the
Commission should require Glenwood to cease accruing carrying charges
on the under-recovered balance until such time that the UEX rate is
updated. Stipulation at 5.

As a matter of clarification, Glenwood and the Staff agree that if Glenwood fails to file
an application to adjust its UEX rider within 30 days of the Commission's order in this
proceeding, that Glenwood will, without a Commission order, cease accruing carrying
charges on the under-recovered balance until such time that the UEX rate is updated.
