APPLICANT'S REPLY TO STAFF'S MEMORANDUM CONTRA TO THE MOTION FOR SUBPOENAS FOR OHIO POWER SITING BOARD STAFF

Pursuant to Ohio Adm.Code 4906-2-23 and 4906-2-27, Kingwood Solar I LLC (the "Applicant") is filing this reply to the Ohio Power Siting Board ("OPSB") Staff's March 4, 2022 memorandum contra to Applicant's motion for subpoenas for various OPSB Staff. In its initial motion filed on February 25, 2022, the Applicant sought subpoenas to require certain members of OPSB Staff and other designated representatives of OPSB Staff, or employees of the Public Utilities Commission of Ohio, to appear at the hearing in this matter. Specifically, the Applicant sought to examine such individuals on various matters related to the Staff Report of Investigation ("Staff Report"), which was issued on October 29, 2021, and the scope and content of communications between the OPSB Staff and any employee of the Public Utilities Commission of Ohio with the Greene County Board of Commissioners or any representative of the Board of Commissioners.

The Applicant now seeks that the Administrative Law Judges ("ALJs") hold their ruling on Applicant's motion in abeyance until OPSB Staff witnesses testify. In its memorandum contra, OPSB Staff indicates that it has filed the testimony of ten separate OPSB Staff witnesses and therefore, the Applicant's request to subpoena the individuals identified in its motion is moot. However, if these ten witnesses are without sufficient knowledge to respond to specific questions regarding the topics outlined in the Applicant's motion, the ALJs should then direct OPSB Staff

to produce the appropriate individual or individuals who can answer these questions during the hearing. Notably, in its motion, the Applicant sought to depose certain individuals who were responsible for various sections in the Staff Report and individuals who spoke to any representative or employee of Greene County, Ohio, during a discrete time period (between October 1, 2021 and October 29, 2021). Therefore, the Applicant requests that the ALJs hold their ruling on Applicant's pending motion until appropriate.
