## MEMORANDUM IN SUPPORT

---

The Staff moves to dismiss this case based on Sangseob Kim (“Respondent”) providing a medical certificate showing he is not required to wear glasses while driving a commercial motor vehicle (“CMV”). Staff also requests that the Commission remove the violation from the Respondent’s history of violations.

On June 7, 2021, a vehicle operated by Schneider National Bulk Carriers Inc, and driven by Respondent was inspected within the State of Ohio. As a result, a violation of 49 C.F.R. § 391.11B(4) was discovered; a driver operating a CMV must wear corrective lenses if required under their medical certificate. On June 8, 2021, pursuant to Ohio Adm.Code 4901:2-7-12, Staff served Respondent with a Notice of Apparent Violation and Intent to Assess Forfeiture. On July 7, 2021, Respondent requested a conference. A conference was held on August 6, 2021. On August 17, 2021, Staff sent Respondent a Notice of Preliminary Determination. Respondent has provided a medical card that shows he does not need to wear corrective lenses while driving a CMV.

After a review of the facts, further investigations, and discussions among Staff, Staff agrees that further prosecution of the violation against Respondent is unwarranted and that the alleged violation should be removed from Respondent’s history of violations. Accordingly, Staff requests that the Commission dismiss the alleged violations in this case and order them to be removed from Respondent’s history of violations.
