

**IN THE MATTER OF: RESOLUTION —DESIGNATING THE RESTRICTED AREAS TO  
PROHIBIT THE CONSTRUCTION OF ANY ECONOMICALLY SIGNIFICANT WIND  
FARMS, LARGE WIND FARMS, OR LARGE SOLAR FACILITY THROUOUT THE  
UNINCORPORATED AREAS OF THE COUNTY AS OUTLINED IN SB52**

Shuff offered the following resolution and moved the adoption of the same, which was duly seconded by Kerschner.

**WHEREAS**, The Seneca County Commissioners, Mr. Kerschner, Mr. Paradiso and Mr. Shuff met in an open and regular session on this 23<sup>rd</sup> day of November 2021, and

**WHEREAS**, It is the desire of this Board to designate the restricted areas to prohibit the construction of any economically significant wind farms, large wind farms, or large solar facilities throughout the unincorporated areas of the county as outlined in Ohio SB52, which was approved during the 134<sup>th</sup> Ohio General Assembly, now therefore be it

**RESOLVED**, That this Board of County Commissioners, Seneca County, Ohio, designates the restricted areas to prohibit the construction of any economically significant wind farms, large wind farms, or large solar facilities throughout the unincorporated areas of the county as outlined in SB52 and in attachment A and be it further




**RESOLVED**, That the Clerk to the Board be and she is hereby authorized and instructed to certify copies of this resolution and required map to all school districts, municipal corporations, and boards of township trustees located in whole, or in part, within the boundaries of the restricted area. She also shall post a map showing the boundaries of the restricted area at all public libraries within the county, the Seneca County Engineer, the Seneca County Auditor, the Seneca County Prosecutor, other agents in line with this action, and be it further

**RESOLVED**, That it is found and determined that all formal action of this Board concerning and relating to the adoption of this resolution were taken in an open meeting of this Board, and that all deliberations of the Board and any of its committees that resulted in such formal actions, were in meetings open to the public, in compliance with the law.
