Ohio Power Siting Board Process

Under Ohio Law, electric generating facilities capable of producing 50 MW or more must apply for a Certificate of Environmental Compatibility and Public Need from the Ohio Power Siting Board (OPSB). The OPSB provides for a single unified process by which facilities can obtain a certificate to operate. Generally speaking, the OPSB process includes a public information meeting, submittal of certificate application, 60-day staff completeness review, application acceptance, OPSB staff review and recommendation, public hearing, adjudicatory hearing, and certificate issuance or denial. There are various avenues for public participation throughout the permitting process. This includes commenting on the docket, attending public hearings, and more.

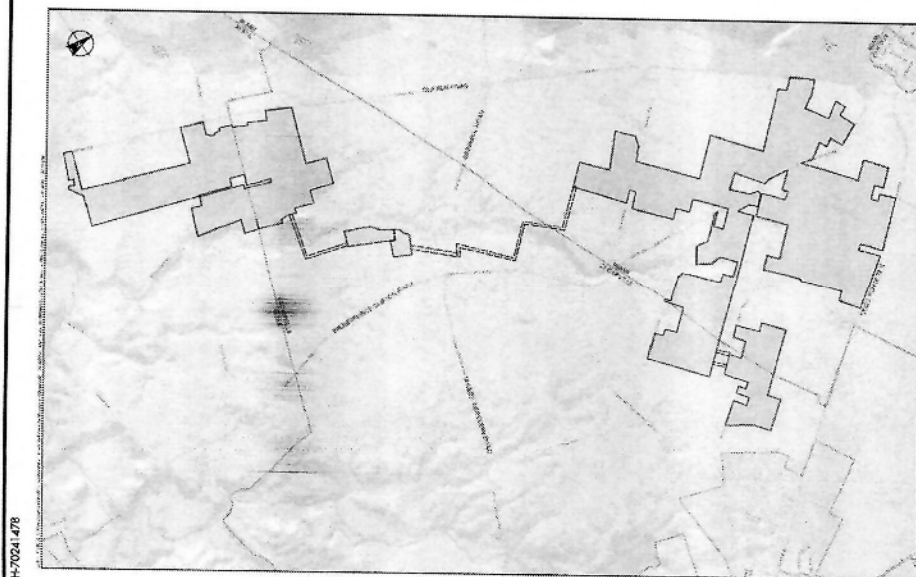


Notice of Public Information Meeting for Proposed Major Utility Facility

Kingwood Solar I LLC ("Kingwood Solar"), a subsidiary of Vesper Energy, has scheduled an in-person public information meeting for June 29, 2021 to outline plans for the Kingwood Solar Project (the "Project"). The proposed Project location is in Cedarville, Miami, and Xenia Townships, Greene County, Ohio (see map below). The Project will use photovoltaic panels and have a total project generating capacity of up to 175 megawatts. The general purpose of the Project is to maximize energy production from solar resources to deliver clean, renewable electricity to the regional transmission system. Kingwood Solar filed its application with the Ohio Power Siting Board on April 16, 2021. Construction is estimated to begin in 2022, with commercial operations in 2023.



comedian was not answered, though the manager forwarded a photograph from Saturday night's taping.

Chappelle came to them June 5, Reichert and Boggar recalled.

Chappelle noted that he'd recently won the Mark Twain Prize in American Humor and Reichert and Boggar had just won an Academy Award for their "American Factory" documentary, concluding, "We're

neighbors. We should work together."

He told them that he had an idea to present a comedy show in a local field.

The lockdown had been in effect for nearly three months at that point. "Comedians have to get in front of audiences," Reichert said Chappelle told them. He said he'd gotten permission that morning from the governor's office, if certain protocols were followed, and he was ready to move forward with giving his idea a try.

"I think it should be documented," Reichert said he told them.

Boggar said the idea was "irresistible," although the pair had been looking forward to a quiet summer after a busy winter and spring that included an awards season honoring "American Factory" and the release of a new film, "9 to 5: The Story of a Movement."

"We love Dave, and we love Dave Date for a long time," Boggar said.

Reichert said their natural next question was, "What?"

"Tomorrow" was Chappelle's answer.

In need of a crew, fast, the filmmakers reached out to their Wright State network.

That first night on the Wing Pavilion stage, before an audience of about 65 invited guests, "Dave had a very powerful talk about George Floyd," Boggar detailed.

Footage from that weekend then became the short film "846," which was shared widely through social media after Netflix posted it to YouTube. The title referred to the originally reported time, eight minutes and 46 seconds, that Minneapolis police officer Daryl Chauvin held his knee on Floyd's neck, causing his death.

Extending the shows

The filmmakers kept shooting as the outdoor shows continued through the summer and into the fall, as Chappelle welcomed a slate of well-known entertainers to the rural setting of 11 Meredith Road.

Chris Rock, Jon Stewart, David Letterman, Trevor Noah, C.K. Lewis, Bob Saget, Tiffany Haddish, and regulars Donnell Rawlings, Michelle Wolf and M. Amer were among the comedians who performed. Musical guests included Common, John Mayer, Erykah Badu and Questlove.

"We did not anticipate what was going to happen," Boggar said of the events that transpired throughout summer 2020. The filmmakers' purpose was to document what unfolded. Although Chappelle served as co-producer, Reichert and Boggar had decided not to film, Boggar said.

"We said the style and the tone. We shaped the film the way we wanted."

Asked if this was their first documentary, Boggar pointed to other projects, including "Sparkle," which focused on Sheryl Williams-Nelson, a longtime dancer with Dayton Contemporary Dance Company, commissioned by CDC and "Making a Man in a Garment," with the Cincinnati Opera.

"We're making films about people who take their art, their craft, their work very seriously," Boggar said. The Chappelle film gave them the opportunity to enter the world of comedy, he said.

"The real gift for us was getting to be inside the culture," he added.

More than 50 shows took place before they came to a close for the season in late September, a week earlier than planned after an unidentified person associated with the performers was reported to have been exposed to COVID-19.

The on-going performances were permitted through a temporary variance from the Miami Township Board of Zoning Appeals, or BZA, after the Township Zoning Inspector notified the property owners that they needed to request such a variance in order to host a commercial activity on land zoned for agricultural use.

The hearing in which the request was considered, and subsequently approved, is reportedly included in the documentary.

Chappelle has more recently hosted an additional dozen shows at the pavilion over three weeks from May 26 through June 12, with tickets at \$60 for a pair. But the venture has apparently come to its conclusion. While the original zoning variance, which set an end date of Oct. 8, 2020, was modified in another BZA hearing to extend into early August this year, the conditions of the modification no longer apply. Specifically, the request cited that the reason for the shows was to provide a place to perform while traditional indoor venues remained closed. The reopening of theaters across the country erases that need.

Making of the film

"We did not anticipate what was going to happen," Boggar said of the events that transpired throughout summer 2020. The filmmakers' purpose was to document what unfolded. Although Chappelle served as co-producer, Reichert and Boggar had decided not to film, Boggar said.

"We said the style and the tone. We shaped the film the way we wanted."

A quality that ties all their films together, Reichert said, is an attempt to "dig deep down" and show the humanity of their subjects. "We don't try to go broad," she said, noting that "The Last Truck" was about the closing of a single factory, "American Factory" features a Chinese businessman opening a glass factory in southern Ohio, and "A Lion in the House" focused on several families whose children were being treated for cancer at the same facility.

Finishing the new film in time to debut at the Tribeca Festival "was a huge effort," Boggar said, adding that they've "never made a big film like this one ever."

The pair worked on it up until the Sunday before its premiere.

Entering it in the Tribeca Festival was also Chappelle's idea, as was its screening at Radio City Music Hall, which had been closed for 15 months until its reopening for the premiere.

"Let's go big," was Chappelle's advice, Boggar said, describing the comedian as a "visionary."

"Dave sometimes sees around a bend before most of us even see a bend coming," Boggar said.

When the Tribeca board accepted the film, and scheduled it to close the film festival, "We were thrilled," Boggar said.

The experience, then, of witnessing the screening was "something just out of this world," he added. "The feeling in that room. We've never experienced anything like that. The laughter — you could feel it in your chest." Premiering the film on June 12th was also meaningful for the pair.

The approximately 6,000-seat hall was the largest space in which they've shown a film, they said. The Schuster Center in Dayton, at 2,500 seats, may have previously been the biggest, Reichert added.

She suggested that the energy Saturday night was heightened by an element to be in a theater setting again.

"There was so much hunger to be out. Everyone in the room was so happy. People were hugging."

Media reports of the evening, noting that patrons had to show proof of vaccination to enter, also added the positive response Reichert and Boggar recall. A variety of media outlets weighed in on the event, many marking the theater's reopening as a momentous moment in the city's life.

NOW, THEREFORE, COUNCIL FOR THE VILLAGE OF YELLOW SPRINGS, OHIO HEREBY ORDAINS THAT:

Section 1. Chapter 674, entitled "Weeds" of the Codified Ordinances of the Village of Yellow Springs, Ohio is repealed.

Section 2. A new Chapter 674 entitled "Weeds and Vegetation" of the Codified Ordinances of the Village of Yellow Springs, Ohio is enacted to read as set forth on the attached and incorporated Exhibit A with new language underlined and bolded and deleted language in strikethrough, along with a new supplemental Appendix of illustrations attached as Exhibit B.

Section 3. This ordinance shall take effect at the earliest date permitted by law.

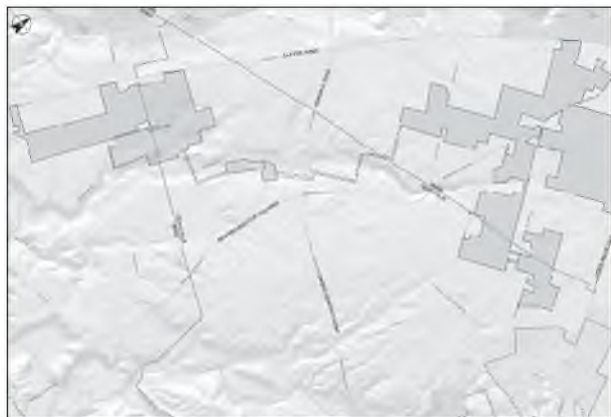

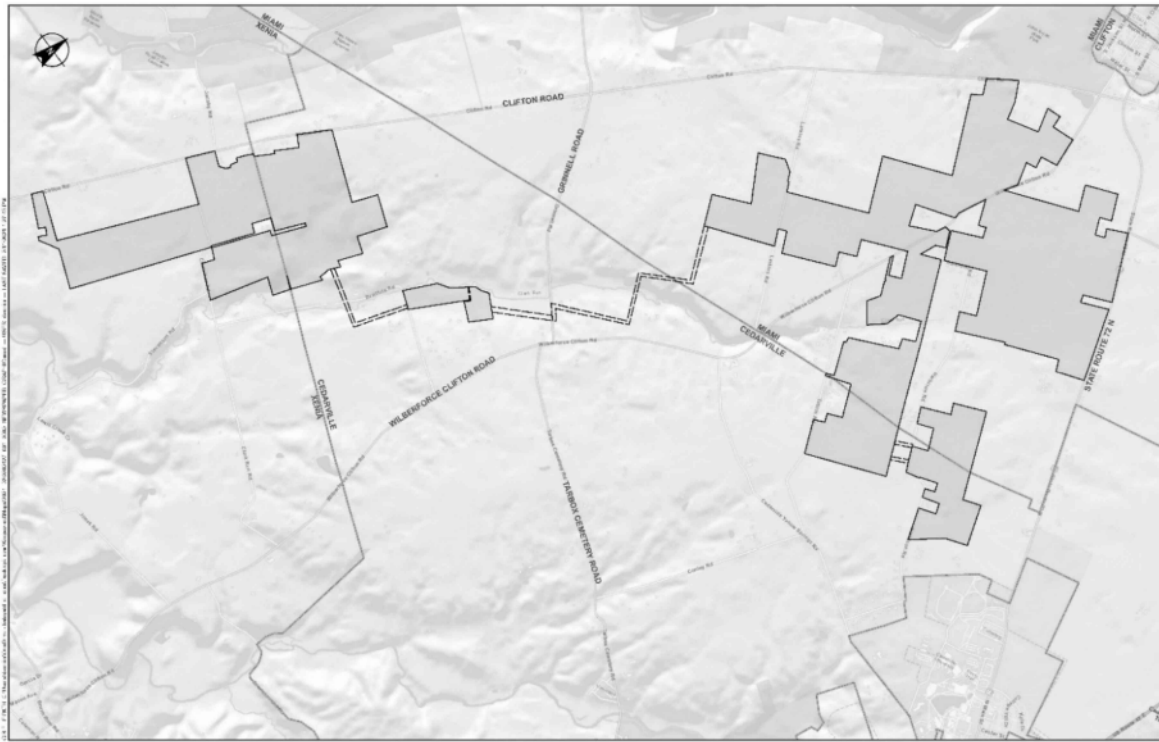

We are contacting you to provide you with additional information about the Kingwood Solar Project (the “Project”). We look forward to additional conversations about the Project, both at the public hearing on November 15, 2021 and at other future events. This letter contains additional information about the Project, the Ohio Power Siting Board process, and upcoming public hearings on the Project.

About the Project

Kingwood Solar I LLC (“Kingwood Solar”), a subsidiary of Vesper Energy, proposes to develop, build, and operate the Project, an up to 175 megawatt solar-powered electric generation facility to be located in Greene County, Ohio. The general purpose of the Project is to maximize energy production from solar resources to deliver clean, renewable electricity to the regional transmission system. The Project will be located within an area of approximately 1,500 acres and will consist of solar panel generators, as well as access roads, 34.5 kilovolt (kV) electrical collector cables, a meteorological station, a facility substation, and a 138-kV electric generation tie (gen-tie) line that will connect to a utility-owned switchyard. The Project is anticipated to positively impact the local economy by producing significant tax revenue and other economic benefits for the area. A map showing the location and general layout of the Project is below.



Kingwood Solar's Application to the Ohio Power Siting Board

Kingwood Solar has filed with the Ohio Power Siting Board (Board) an application for a Certificate of Environmental Compatibility and Public Need to construct, operate, and maintain the Project in Case No. 21-0117-EL-BGN, which is now pending before the Board. Copies of the application were served upon the Greene County Board of Commissioners, Xenia Township Board of Trustees, Cedarville Township Board of Trustees, Miami Township Board of Trustees, Greene County Soil and Water Conservation District, Greene County Regional Planning and Coordinating Commission, Greene County Department of Development, and Greene County Community Improvement Corporation. A copy of the application was also provided to and is available for public review at the Xenia Community Library, the Cedarville Community Library, and the Yellow Springs Community Library. Ohio Power Siting Board Criteria

The Board utilizes the following criteria for reviewing an application for a major utility facility:

1. The basis of the need for the facility if the facility is an electric transmission line or gas pipeline;
2. The nature of the probable environmental impact;
3. That the facility represents the minimum adverse environmental impact, considering the state of available technology and the nature and economics of the various alternatives, and other pertinent considerations;
4. In the case of an electric transmission line or generating facility, that the facility is consistent with regional plans for expansion of the electric power grid of the electric systems serving this state and interconnected utility systems and that the facility will serve the interests of electric system economy and reliability;
5. That the facility will comply with Chapters 3704., 3734., and 6111. of the Revised Code and all rules and standards adopted under those chapters and under section 4561.32 of the Revised Code. In determining whether the facility will comply with all rules and standards adopted under section 4561.32 of the Revised Code, the board shall consult with the office of aviation of the division of multi-modal planning and programs of the department of transportation under section 4561.341 of the Revised Code.
6. That the facility will serve the public interest, convenience, and necessity;
7. In addition to the provisions contained in divisions (A)(1) to (6) of this section and rules adopted under those divisions, what its impact will be on the viability as agricultural land of any land in an existing agricultural district established under Chapter 929. of the Revised Code that is located within the site and alternative site of the proposed major utility facility. Rules adopted to evaluate impact under division (A)(7) of this section shall not require the compilation, creation, submission, or production of any information, document, or other data pertaining to land not located within the site and alternative site.
8. That the facility incorporates maximum feasible water conservation practices as determined by the board, considering available technology and the nature and economics of the various alternatives.

Notification of Public Hearings

The public will be given an opportunity to comment on the proposed Project. The public hearing for this proceeding shall consist of two parts:

1. A local public hearing, pursuant to R.C. 4906.08(C), where the Board shall accept written or oral testimony from any person, commencing November 15, 2021, at 6:00 p.m., in the Assembly Hall of the Greene County Expo Center, 120 Fairground Rd., Xenia, Ohio 45385; and
2. An adjudicatory hearing to commence on December 13, 2021, at 10:00 a.m., 11th Floor, Hearing Room 11-A, at the offices of the Public Utilities Commission of Ohio, 180 East Broad Street, Columbus, Ohio 43215-3793. To participate in the adjudicatory hearing, intervention in the case is necessary.

The Board has also issued guidelines for attendance at the hearings: Consistent with Centers for Disease Control and Prevention Guidelines and the May 17, 2021 Ohio Department of Health Order, attendees must abide by mitigation measures required by the venue, and individuals who are not fully vaccinated should continue to wear a face covering and socially distance.

Intervention

Petitions to intervene in the evidentiary hearing will be accepted by the Board up to 30 days following service of the notice required by R.C. 4906.06(C) and Ohio Adm.Code 4906-3-09, or October 8, 2021, whichever is later. However, the Board strongly encourages interested persons who wish to intervene in the adjudicatory hearing to file their petitions as soon as possible. Petitions should be addressed to Docketing Division, the Ohio Power Siting Board, 180 East Broad Street, Columbus, Ohio 43215-3793 and cite the above-listed case number.
