Direct Testimony of Angela Zeisig

1	I.	INTRODUCTION
2	Q1.	Please state your name, occupation and business address.
3	A.	My name is Angela Zeisig. I am employed by The East Ohio Gas Company d/b/a
4		Dominion Energy Ohio (DEO or the Company) as Supervisor, Customer Service Center.
5		My business address is 1201 E. 55th Street, Cleveland, Ohio 44103.
6	Q2.	Please describe your work history.
7	A.	I have been employed by DEO since 2008 in various positions related to customer
8		service, including Call Center Representative, Customer Relations Representative,
9		Permitting and Restoration Control Specialist, and Supervisor, Integrated Service Center.
10	Q3.	What are your responsibilities as Supervisor, Integrated Service Center?
11	A.	I am responsible for the supervision of Customer Relations Representatives, including
12		overseeing the response to informal and formal complaints.
13	Q4.	Have you previously testified before any state regulatory commission?
14	A.	No. I have not previously testified before either the Public Utilities Commission of Ohio
15		(PUCO or Commission) or any other state regulatory commission.
16	Q5.	What is the purpose of your testimony?
17	A.	My testimony explains the history for Mr. Boyce Parker's account and natural gas service
18		for the relevant time period. My testimony concludes that Mr. Parker's account was
19		properly billed for natural gas service for the time period in question.
20	Q6.	What information have you reviewed to prepare your testimony?
21	A.	I have reviewed the formal complaint forms that Mr. Parker submitted, which were filed
22		in this docket on November 9, 2021, and January 10, 2022 (collectively, the Complaint).

I also reviewed DEO's Answer filed November 21, 2021, and DEO's correspondence

1		filed on February 11, 2022. In addition, I reviewed Mr. Parker's account history for the
2		relevant time period, as documented in DEO's customer information systems, and Mr.
3		Parker's billing statements for the period January 2021 through December 2021.
4	Q7.	What is your understanding of the dispute giving rise to the Complaint?
5	A.	Mr. Parker's original complaint was not clear, and included a notice from and potential
6		allegations concerning NOPEC, a governmental aggregator. Mr. Parker was not enrolled
7		in NOPEC during the time period under review, and the inclusion of the NOPEC notice
8		may have reflected a misunderstanding. Based on DEO's communications with Mr.
9		Parker and additional correspondence filed by Mr. Parker, DEO believes that Mr.
10		Parker's concerns are with his transition from Standard Service Offer (SSO) commodity
11		service to Standard Choice Offer (SCO) commodity service in the middle of 2021. In
12		particular, Mr. Parker seems to allege that DEO incorrectly billed him for charges from
13		Barracuda Energy LLC (Barracuda Energy) related to his natural gas commodity service.
14		His pleadings included attachments of bills on his account that were prepared on
15		September 22, 2021, October 25, 2021, and December 23, 2021.
16	Q8.	Have you included any exhibits with your testimony?
17	A.	Yes. DEO Exhibit 1.1 contains copies of Mr. Parker's bills for 2021. DEO Exhibit 1.2 is
18		a copy of the postcard that DEO sent to Mr. Parker notifying him of the assignment of
19		Barracuda Energy for his natural gas supply. DEO Exhibit 1.3 is a copy of Mr. Parker's
20		Account Statement for 2021. Mr. Parker's address and account number have been

redacted from these documents.

II. DEO ACCOUNTS AND RECORDS

1

- 2 Q9. Do you have knowledge of the history of Mr. Parker's account with DEO?
- 3 A. Yes. I am familiar with the Company's records for the relevant time period pertaining to
- 4 Mr. Parker's account. And I have personal knowledge of DEO's practices of acquiring
- 5 and maintaining this information. DEO maintains numerous types of information
- 6 regarding each customer's account, including meter readings, billing and payment
- 7 history, dates of initiation and disconnection of service, and communications to and from
- 8 customers. All such information is recorded at or near the time by a person with
- knowledge, or from information transmitted by a person with knowledge, and all such
- information is recorded and maintained in the course of DEO's regularly conducted
- business activity. It is DEO's regular practice in the course of its business activity to
- record and keep the sorts of information I relied upon in preparing this testimony.

13 III. ACCOUNT HISTORY

- 14 Q10. Please summarize the natural gas service that Mr. Parker received in 2021.
- 15 A. At the beginning of 2021, Mr. Parker was enrolled in the Percentage of Income Payment
- Program (PIPP Plus). On May 24, 2021, however Mr. Parker was removed from PIPP
- Plus for not meeting the program's income verification requirements. After voluntarily
- declining to be enrolled in the Graduate PIPP Plus program, Mr. Parker was enrolled with
- Barracuda Energy as his Standard Choice Offer (SCO) supplier in July 2021 and
- remained enrolled with Barracuda Energy for his supply service for the remainder of
- 21 2021.

2	QII.	the assigned supplier, Barracuda Energy?
3	A.	As shown in DEO Exhibit 1.1 for Mr. Parker's bills prepared through July 27, 2021, prior
4		to being enrolled in SCO service, Mr. Parker received service under the Company's
5		Standard Service Offer (SSO). This included both the time Mr. Parker was enrolled in
6		PIPP Plus, and then a transition period before beginning SCO service.
7	Q12.	Did those SSO bills contain charges for both the delivery and supply of natural gas?
8	A.	Yes. The SSO bills indicated that the bill amount included charges for SSO gas cost
9		based on Mr. Parker's usage, as well as both a fixed monthly service charge and
10		volumetric riders ("usage based charges") for DEO's delivery of the gas.
11 12	Q13.	Did Mr. Parker receive notice that his account was assigned to Barracuda Energy, LLC at its Standard Choice Offer (SCO) rate?
13	A.	Yes. As shown in DEO Exhibit 1.2, Mr. Parker was notified of the assignment to
14		Barracuda Energy, LLC on July 29, 2021.
15 16	Q14.	Is it your understanding that the assignment of Mr. Parker's account was consistent with the Company's tariffs?
17	A.	Yes. Although I have been informed by counsel that interpretation of the tariffs is a
18		question of law and I am not a lawyer, my understanding is that DEO's approved tariffs
19		provide for residential customers who do not select another supply option to be assigned
20		to an SCO supplier, following up to two SSO bills. Mr. Parker's bills were consistent
21		with this. After Mr. Parker's account was removed from PIPP Plus, his bills prepared on
22		June 23, 2021, and July 27, 2021, indicated that if after two consecutive bills he had not
23		selected an Energy Choice supplier, his account would be placed on the SCO rate and his
24		gas would be supplied by an approved certified supplier.

1	Q15.	Does the SCO rate differ from the SSO rate?
2	A.	No. My understanding is that each month, the SCO rate and the SSO rate are the same.
3 4	Q16.	During what period of time does Mr. Parker claim that DEO overbilled him for service?
5	A.	According to Mr. Parker's Complaint, he believes that he was overbilled from the time
6		that he was assigned to Barracuda Energy under the SCO. During 2021, the time period
7		during which Mr. Parker was billed charges for Barracuda Energy covers his bills
8		prepared August 23, 2021 through December 23, 2021, which can be found in DEO
9		Exhibit 1.1.
10	Q17.	Did Mr. Parker's bills properly reflect charges from Barracuda Energy?
11	A.	Yes. Once Mr. Parker's account was assigned to Barracuda Energy, the supplier was
12		responsible for arranging commodity supply under the SCO rate, with DEO including
13		Barracuda's charges on the bill. The 2021 bills for the time period during which Mr.
14		Parker's account was assigned to Barracuda Energy properly reflect the SCO charges that
15		Mr. Parker owed for his natural gas usage.
16 17	Q18.	Once Mr. Parker's account was assigned to Barracuda Energy, his bills still show Usage-Based Charges from DEO. What do those charges represent?
18	A.	These charges reflect various riders that are charged on a volumetric basis. They are not
19		associated with the natural gas commodity.
20	Q19.	Were these billed amounts also reflected in DEO's billing system?
21	A.	Yes. A comparison of Mr. Parker's 2021 bills to his account statement, which is shown in
22		DEO Exhibit 1.3, shows that DEO's billing system reflected the same amounts billed to
23		Mr. Parker. I did not identify any error in the rates or the quantities billed to Mr. Parker's
24		account.

- 1 Q20. Was Mr. Parker ever charged twice for the same gas or service during this time period?
- 3 A. No. The charges on Mr. Parker's bills from Barracuda Energy pertain to the natural gas
- 4 commodity itself, and the charges from DEO pertain to the delivery of that commodity.
- 5 Q21. Does this conclude your direct testimony?
- 6 A. Yes, it does.

The MRR rate is recalculated monthly and reflects the lower of the assigned supplier's lowest monthly variable rate offer and the median price offered by participating suppliers.

Reconnection Fee - Fee charged to restore gas service that was terminated by the Company or at a customer's request.

Reset Read - Adjusted meter reading that establishes the point from which you are responsible for gas use.

Returned Payment Fee - Fee for each returned item tendered or authorized as payment on the customer's account and returned for any reason. Security Deposit Installment - One-third of the total security deposit required. Security deposits are billed to customers in three equal monthly installments. A 3% rate of interest is paid if the full deposit is held for 180 days or longer. Deposits are refunded with interest to residential and small commercial accounts if required payments are made for 12 consecutive months and were not late more than two months during that time, you are not delinquent, or an account is closed for 10 days or longer. Deposits for large commercial and industrial accounts are reviewed every 24 months. Service Charge - This charge includes fixed costs for delivering gas.

Standard Choice Offer (SCO) - Cost of acquiring default natural gas for sale to Energy Choice-eligible residential customers by a participating supplier assigned by Dominion Energy Ohio to provide gas supply at the regulated rate.

Standard Service Offer (SSO) - Cost of acquiring natural gas for sale to customers who purchase gas from Dominion Energy Ohio.

Tax Savings Credit - This credit is being provided to pass on 100% of the tax savings Dominion Energy Ohio gained through federal tax reform effective January 1, 2018.

Transportation Charges / Usage-Based Charges - Cover costs associated with delivering gas to the meter, including all applicable riders and taxes. All customers are required to pay these charges regardless if they choose an alternate supplier through the Energy Choice or other transport programs. These charges do not include the cost of the gas.
