On climate change

The story the world faces a climate change crisis is largely peddled in summaries of climate change assessment reports by the United Nations' Intergovernmental Panel on Climate Change, composed of enviro-crats from member nations, or by the U.S. Global Change Research Program, a joint task force of various environmental bureaucracies. These assessment reports are not peer reviewed.

Though lots of experts make comments, lead report authors can reject them. The bureaucrats select friendly, reliable lead author scientists for the summaries and can further massage the message. Fortunately, they don't tend to change the science documented in the reports (yet), much of which

contradicts the summaries' alarm.

I've read such sporadic accounts for at least 15 years, so Dr. Steven Koonin didn't discover this. The value of his book "Unsettled: What Climate Science Tells Us, What It Doesn't, and Why It Matters" is its discussion of numerous examples where the reports' (and other peer reviewed studies') documented science contradicts the summaries' alarm.

Yet the summaries are all the Left/Green "mainstream" media reads and reports. Warming is in fact moderate, and disastrous weather globally remains within historical

ranges.

Koonin lays bare the workings of the climate models, which are still the only source of climate crisis forecasts. Small-scale but critical phenomena (clouds, storms, etc.) cannot be usefully modeled, so the models don't get current temperatures or the past century's warming trend variations right.

Their forecasts are worthless.

Most of Koonin's peer reviewed papers since 2000 (check NYU Scholars) are climate or alternative energy related. He writes that he came to climate science (an incredibly interdisciplinary field) from physics, just as some darling scientists of the Green Left did (not his wording). His long scientific career, including serving as BP's chief scientist for its "Beyond Petroleum" initiative and his service as Undersecretary for Science at the Energy Department under Obama, is reported to have been quite illustrious, so fame and fortune likely did not motivate him to write the book so much as his strong dedication to scientific integrity.

He strongly advocates more research to develop reliable and economical alternative energy, but because it doesn't yet exist, he guarantees fossil fuel use worldwide will rise this century, since developing countries must use economical and reliable energy.
