Ross County Solar, LLC (Ross County Solar) is certified to construct a 120 MW solar-powered electric generation facility in Ross County, Ohio. Ross County Solar is submitting this correspondence to show compliance with Certificate Condition 12. For reference, Certificate Condition 12 is listed below:

The Applicant shall not commence any construction of the facility until it has executed an Interconnection Service Agreement and Interconnection Construction Service Agreement with PJM Interconnection, which includes construction, operation, and maintenance of system upgrades necessary to integrate the proposed generating facility into the regional transmission system reliably and safely. The Applicant shall docket in the case record a letter stating that each agreement has been signed or a copy of the executed Interconnection Service Agreement and Interconnection Construction Service Agreement.

In accordance with Certificate Condition 12, this letter is confirming that both the Interconnection Services Agreement and Interconnection Construction Services Agreement for the Project have been executed between Ross County Solar, LLC, PJM Interconnection, and AEP Ohio Transmission Company, Inc.
