Narrative Summarizing Change(s)

In this application, Glandorf Telephone Company, Inc., a for-profit ILEC, increases its BLES Monthly Rates by \$2.00 for residential and business customers. This increase results in BLES Monthly Rates that are equal to their corresponding BLES Rate Caps for the current 12-month period, consistent with Rule 1406:1-9-14 (E)(2).

Glandorf Telephone Company, Inc. received BLES pricing flexibility effective October 1, 2017, in Case No. 17-1883-TP-BLS. Its most recent increase in residential and business BLES rates was effective October 1, 2017.

Customer Notice and Affidavit

The following customer notice was provided to customers on February 1, 2022. This notice was also sent to the Commission's electronic mailbox and to the Office of the Ohio Consumers' Counsel.
