**NOTICE OF SUGGESTION OF BANKRUPTCY**

**PLEASE TAKE NOTICE**, that, commencing May 9, 2022, Respondent Talen Energy Marketing, LLC (along with its debtor affiliates, the “**Debtors**”) filed voluntary petitions for relief (the “**Chapter 11 Cases**”) in the United States Bankruptcy Court for the Southern District of Texas (the “**Bankruptcy Court**”) under chapter 11 of title 11 of the United States Code (11 U.S.C. § 101, et seq.) (the “**Bankruptcy Code**”). The Debtors’ Chapter 11 Cases are jointly administered under Case Number 22-90054. Copies of the Debtors’ chapter 11 petitions are available on the website of the Debtors’ proposed claims and noticing agent at <https://cases.ra.kroll.com/talenenergy>.<sup>1</sup>

**PLEASE TAKE FURTHER NOTICE**, that pursuant to section 362(a) of the Bankruptcy Code (the “**Automatic Stay**”), the filing of the chapter 11 bankruptcy petitions “operates as a stay, applicable to all entities,” of, among other things, “the commencement or continuation, including the issuance or employment of process, of a judicial, administrative, or other action or proceeding

against the debtor that was or could have been commenced before the commencement of the case under [the Bankruptcy Code], or to recover a claim against the debtor that arose before the commencement of the [bankruptcy] case” and “any act to obtain possession of property of the estate or of property from the estate or to exercise control over property of the estate[.]” 11 U.S.C. § 362(a)(1), (3).

**PLEASE TAKE FURTHER NOTICE**, that any action against the Debtors or to obtain possession of property of the Debtor’s estate or exercise control over property of the Debtor’s estate, without obtaining from the Bankruptcy Court, relief from the Automatic Stay is void *ab initio* and may result in a finding of contempt for violation of the Automatic Stay. The Debtors reserve and retain their statutory rights to seek relief in the Bankruptcy Court from any action by Plaintiffs or any judgment, order, or ruling entered in violation of the Automatic Stay.
