1 1. Q. Please state your name and business address.

2 A. My name is Eric Morrison, and my business address is 180 East Broad Street,
3 Columbus OH 43215.

5 2. Q. By whom are you employed and what is your position?

6 A. I am employed by the Public Utilities Commission of Ohio (Commission) as
7 a Utilities Specialist 1 within the Power Siting Department.

9 3. Q. Please summarize your educational background and work experience.

10 A. I received a Bachelor of Specialized Studies Degree in Civil Engineering and
11 Business from Ohio University in Athens, Ohio.

13 I have been employed by the PUCO since March 2017. My responsibilities
14 during this time have primarily involved review of Power Siting cases.

16 4. Q. Have you testified in prior proceedings before the Board?

17 A. Yes. I have testified in numerous proceedings before the Board.

19 5. Q. What is the purpose of your testimony in this proceeding?

20 A. I am sponsoring portions of the Staff Report of Investigation (Staff Report)
21 that was filed in the docket of this case on April 18, 2022. Specifically, I

1 am sponsoring the Staff Report subsections titled “Agricultural Districts
2 and Land”, “Roads and Bridges”, and “Air, Water, and Solid Waste.”

4 6. Q. Are you responsible for any specific conditions in the Staff Report? If so,
5 which ones?

6 A. Yes. I am responsible for conditions 11 and 21.

8 7. Q. Why is Staff recommending condition 11?

9 A. This condition ensures the Applicant shall coordinate with the proper
10 regulatory authority concerning project activity that affects transportation
11 infrastructure. It also requires the Applicant to supply Power Siting Staff with
12 a transportation management plan prior to construction.

14 8. Q. Why is Staff recommending condition 21?

15 A. This condition outlines the requirements the Applicant must meet to mitigate
16 disruption of agricultural field drain tile systems.
17

18 9. Q. Does this conclude your testimony?

19 A. Yes, it does. However, I reserve the right to submit supplemental
20 testimony, as new information subsequently becomes available or in
21 response to positions taken by other parties.
