OHIO EDISON COMPANY, THE CLEVELAND ELECTRIC ILLUMINATING COMPANY, AND THE TOLEDO EDISON COMPANY'S MEMORANDUM CONTRA MOTION TO STRIKE BY THE OFFICE OF THE OHIO CONSUMERS' COUNSEL

Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company (the "Companies") moved to protect information ¹ expressly designated as confidential by third-parties Daymark Energy Advisors ("Daymark") and Oxford Advisors LLC ("Oxford") consistent with O.A.C. 4901-1-24(A) and ¶ 3 of the parties' Protective Agreement. ² While the information the Office of the Ohio Consumers' Counsel ("OCC") seeks to make public does not belong to the Companies, the Companies' motion enables Daymark and Oxford to advocate for its continued confidentiality. Yet, OCC asserts the Companies "oddly" "violated [the Commission's] rule by not including the sworn affidavit of counsel that the rule requires" and as a result, "[the Companies'] motion should be stricken." OCC's argument is without merit and its Motion to Strike should be denied.

As previously stated, the Companies complied with the terms of the parties' Protective Agreement to the best of their ability—but they cannot submit an affidavit concerning information that is not their own. Doing so would be at odds with the parties' Agreement, which allows *either side* to seek protection for *third-party information*. Any meet and confer between the Companies and OCC would have been futile as the Companies have no independent interest in maintaining these documents' confidentiality and no way to negotiate away rights belonging to the auditors.

"[T]he Companies [we]re not in a position to unilaterally disclose Daymark's and Oxford's commercially sensitive or proprietary information," and they have no independent desire to keep it secret. Rather, the Companies, having produced this information to OCC consistent with Daymark's and Oxford's confidential designations, filed their Motion to give Daymark and Oxford time to support their designation of the information as confidential. Accordingly, the Companies respectfully request that OCC's Motion to Strike be denied.
