As a customer of Columbia Gas, I find their proposal to raise the monthly distribution charge outrageous. Slowly increasing this fee from \$17 to \$80, before even accounting for the natural gas I use to heat my home and cook food for my family, will make a real difference in our ability to budget and pay our bills, and I know we aren't alone. This is a total money grab from Columbia, and a perfect example of the greediness of these corporations that all want to profit exorbitantly at the expense of their middle and lower-class customers. I am happy to pay for the amount of product I use and the reasonable service fees associated with that, but I don't think I should be paying for Columbia Gas executives to profit over

\$200 million and reward themselves lavish bonuses. Please strike down this proposal and limit them to a reasonable increase.
