With such a HUGE increase, we will never be able to come close to breaking even. The massive increase will require us, and every customer, to have at least an additional \$30 added to their budget. In our case, that extra \$30 will amount to a 34+ percent increase to the monthly budget bill. Our Social Security did not, and will not, increase 34+ percent. Not even more sweaters and blankets will help us, as this increase will continue to take, and take, and take.
