Description: The rate hike that Columbia Gas is proposing is outlandish and should immediately be shot down. In a time where natural gas prices have more-than-tripled, petroleum has reached never-before-seen prices, electric rates doubled, and the cost of living in general has become insanely expensive, Columbia Gas wants to charge us \$46 BEFORE metering?! Absolutely not!

My gas bill was always my cheapest bill with it coming in around \$45 during peak

winter months. This year, I had a bill that was \$105 for LESS usage. And they want to raise that another \$30???? This is criminal. Public utilities being provided by for-profit companies is already gross as it is, but this is disgusting.

They say this is for infrastructure replacement, but they already charge us an infrastructure replacement rider fee before the meter is read. This here is literally nothing but the C-suite getting jealous of Big Oil and wanting their slice of the record-breaking profit pie.

Please do right by Ohioans and tell Columbia Gas NO on this ridiculous proposal.
