Description: I do not believe the proposed price increase by Columbia Gas is honest, not good for consumers. There is already a fixed price for delivery. Meaning that if no gas is even delivered or used, then they still get money. In the case where someone moves in the middle of a billing cycle, they charge this twice to that consumer. Also, there are already "infrastructure" fees added to the bill, totaling roughly \$40 every month. This increase is purely for profit, and consumers should not be the ones paying for this company's continued money grubbing.
