It's VERY UNFAIR that we have to pay a minimum balance no matter what, and now their are raising the rates. We only use gas to cook off of in summer, cook and heat in the winter. When we first moved here, our bill averages \$9-\$12 in summer and \$120-\$150 in winter. Now, we have to pay a minimum of approx \$30 a month plus usage because we are "hooked up". Just because I am "hooked up" to the phone line, they don't charge a minimum. Just because I am "hooked up" to the electric pole, they don't charge a minimum. Now, rates are going up AGAIN!! Somewhere, this has to stop!! I should not pay just because I am "hooked up", I should only pay for what I use!! I am also thinking of filing a

complaint with atty general as well if something is not resolved for not only us, but everyone else that is "hooked up". Thank you for your time, it is GREATLY appreciated!
