Description: I am a resident and consumer of Columbia Gas. I am appalled at the proposal to increase the charges on distribution for households receiving this service when we do not even receive the benefits of the increased charges. Columbia gas does not provide us with additional better service from these charges. They also have a monopoly on the gas utility in this city - they do NOT need more money. Columbia should be taxed more for using so much gas. There is also no protection for folks who already struggle to pay their gas bill. I cannot afford an additional \$30 and I cannot afford a utility shut off, and I know several people who might even face eviction or shutoff if this occurs because they would not be able to pay. Columbia should be ashamed.
