Dear Secretary MacNeal:

Pursuant to the Federal Communications Commission's October 9, 2020 *Report and Order* in WC Docket No. 18-156, FCC 20-143, ("8YY R&O"), Section 51.911(c) of the Federal Communications Commission's rules, 47 C.F.R. §51.911(c), and the Public Utilities Commission of Ohio's ("Commission") June 1, 2022 *Entry* in Case No. 10-2387-TP-COI,<sup>1</sup> Granite Telecommunications, LLC ("Granite") submits to the Commission amended Sheet Nos. 1 and 55 to Granite's Ohio switched exchange access tariff, P.U.C.O. Tariff No. 2.

By this submission, Granite complies with the 8YY R&O, and Commission's *Entry* by setting Toll Free ("8YY") Data Base Access Service rates at parity with corresponding incumbent local exchange carrier rates in Granite's Ohio operating territory, as reflected in Granite's interstate switched exchange access tariff, Tariff F.C.C. No. 1., effective July 1, 2022. Granite's 8YY and Terminating Access rates are already benchmarked to the Company's Tariff F.C.C. No. 1, and to the corresponding rates that become effective July 1, 2022.
