I already filed a public comment and testified at a public hearing but my comment seems not to have made it onto the case docket. I strongly oppose this rate increase. I already pay a minimum of \$40 a month for Columbia even when I use virtually no gas. A huge proportion of my bill is comprised of fixed charges. This rate increase is exorbitant and a shocking display of greed. And it comes as millions are already being crushed by inflation and low income people in particular are struggling to pay bills. I strongly urge PUCO to go with the Ohio Consumers' Counsel plan for Columbia. This company faces no competition, is unaccountable

to its ratepayers, and makes hundreds of millions of dollars in profit every year. I refuse to allow it to pocket any more of our money.
