Dear Chairman French,

The Dayton Power and Light Company doing business as AES Ohio submits this notice to inform you of the following correspondence to satisfy Conditions 4 and 5 related to the March 18, 2022 Ohio Power Siting Board (“OPSB”) approval of the above-referenced project. On July 7, 2022, AES Ohio notified Dayton International Airport of the commencement of construction of the above-referenced project (which will initially involve low-level brush and tree clearing) and of construction using cranes projected to begin in November (Enclosures 1 & 2). The exact dates of crane operation, crane height, and additional operating conditions are forthcoming, and AES Ohio will follow up with Dayton International Airport once that information is finalized.

The FAA determination of no hazard to air navigation regarding cranes used during construction is forthcoming. AES Ohio will submit those authorizations to satisfy Condition 4 once obtained.

AES Ohio anticipates that construction of the Project will commence as soon as July 18, 2022.


Dear Mike Cross,

The Dayton Power and Light Company doing business as AES Ohio submits this notice to inform you construction will begin on the West Milton – Airport and the Airport – Miami 138kV transmission lines later this month (July 2022). These lines will be constructed north of the Dayton International Airport on Ginhamsburg-Frederick, Bard, and Peters Roads. Additional information on these projects can be found here (<https://www.aes-ohio.com/transmission-improvements>). Initial work will consist of vegetation clearing.

Physical construction of the transmission line is expected to begin in the September/October time frame, and a crane is expected to be in use in November/December. As the exact dates of crane operation are known, as well as the crane height and operating conditions, that information will be provided to you and to the FAA for a Determination of No Hazard.
