I am commenting on Columbia Gas proposed rate hikes. Case numbers - 21-0637-GA-AIR, 21-0638-GA-ALT, 21-0639-GA-UNC, 21-0640-GA-AAM

I am firmly opposed to this rate hike. Columbia gas is still posting profits while being a monopoly. I understand raising rates, but not from \$17 to \$46. That is too steep, also distribution charges are unfair. They should rather be raising the price of natural gas to make those who use more to pay their fair share.

In addition, Columbia gas is bringing out specific non-profits to bolster this case. Please see text from a columbus underground article written on july 12, 2022 about the non-profits that were supporting Columbia gas.

"Columbia Gas and its parent company NiSource hold or have held seats on the boards of each of the nonprofits present — a fact which may have played a role in their decisions to testify. OEP, Children's Hunger Alliance, LifeCare, United Way of Central Ohio, and Besa all currently have associates of these companies on their boards (though LifeCare's board list does not display affiliations, William E. Mojica is a Senior Vice President at NiSource). Although no Columbia Gas representatives are currently listed on CSB's board, archived pages indicate that Columbia Gas' Darnita M. Bradley served in 2019 and Sherrice Thomas from 2020-2021. In testimony, both Marshall of the Children's Hunger Alliance and Garver of CSB openly mentioned Columbia Gas' board involvement as positive examples of philanthropic engagement."

This is a shady proposal that will hurt already hurting Ohioans. Inflation is too high, pay raises are not meeting the COL increases, and an outrageous housing market is trapping citizens into renting.

Nisource posted a 152 million profit in the fourth quarter alone of 2021


