Dear Ms. Troupe:

Pursuant to Ohio Administrative Code ("O.A.C.") Rule 4906-3-03(A), Oak Run Solar Project, LLC ("Applicant" or "Oak Run Solar") files this Second Preapplication Notification Letter with the Ohio Power Siting Board ("OPSB") regarding its proposed solar generation and transmission line facilities to be located in Monroe, Somerford, and Deercreek Townships, Madison County, Ohio.

The Oak Run Solar generation facility (Case No. 22-549-EL-BGN) will be sited on approximately 6,060 acres and have a maximum total generating capacity of up to 800 megawatts ("MWs"), including associated transmission lines and substations. The Project may also include an advanced battery system up to 300 MWs in size. The purpose of the facility is to generate electricity to inject into the local transmission grid. Construction is anticipated to begin as early as the fourth quarter of 2023, resulting in commercial operations as early as the fourth quarter of 2025.

The Oak Run Solar transmission line (Case No. 22-550-EL-BTX) will support the Oak Run Solar generation facility (Case No. 22-549-EL-BGN) and will be a 230 kilovolt ("kV") line that will be approximately 3.5 miles long within the Project boundary. There will be two Project collection substations. The transmission route will begin at each of the two Project collection substations, joining together near Urbana-West Jefferson Road within the generation facility footprint, approximately 1 mile southwest of the Village of Plumwood, before continuing east to

the Project step-up substation. The alternate route is also anticipated to initiate at the Project substations and terminate at the Project step-up substation and, while it is still being developed, it will likely be configured and located similar to the preferred route, but further to the north, as shown in the map below. Construction of the transmission line is estimated to begin in the fourth quarter of 2023 and be completed in the fourth quarter of 2025. The primary purpose of the transmission line is to deliver up to 800 MWs of clean, renewable electricity from the Oak Run generation facility to the regional electric grid to serve the needs of electric utilities and their customers.

On August 2, 2022, Oak Run Solar will host a second public information meeting for the generation and transmission line facilities. The public information meeting will take place from 4:30 p.m. to 7:00 p.m., at the Monroe Elementary School in Plumwood, Ohio, 5000 OH-38, London, Ohio 43140. Information describing the facility will be made available through an open house, posterboard session format. Attendees may arrive anytime between 4:30 p.m. and 7 p.m. to engage with Oak Run Solar representatives on hand to answer questions regarding the facilities.

At this time, the Applicant has not determined whether it will be filing any requests for waiver from the Board's rules regarding the electric generation or transmission facility application to be filed with the Board in addition to waiver requested on May 26, 2022.
