**MEMORANDUM IN SUPPORT OF
THE JOINT MOTION TO SUSPEND PROCEDURAL SCHEDULE**

On January 5, 2022, Sportsman's Market, Inc. ("Sporty's") and Brian Jobe (collectively, "Respondents") submitted a request for an administrative hearing with the Public Utilities Commission of Ohio ("Commission") in this proceeding. By Entry dated April 22, 2022, the administrative law judge ("ALJ") established a procedural schedule with the hearing set to be held on July 20, 2022. Commission Staff and Respondents now respectfully request that the procedure schedule be stayed to allow the parties to continue settlement negotiations. The parties will provide the ALJ with a status update via email on or before September 19, 2022. At this time, the parties will also provide the ALJ with mutually agreeable dates for a rescheduled hearing, if necessary.

Pursuant to Ohio Adm.Code 49011-12(C), the parties also request expedited treatment of this motion as the current hearing is set to be held this week on July 20, 2022. No other parties have intervened in this proceeding, so the ALJ may issue an expedited ruling.
