**STATEMENT OF VECTREN ENERGY DELIVERY OF OHIO, INC. D/B/A
CENTERPOINT ENERGY OHIO INFORMING THE COMMISSION
WHETHER THE ISSUES RAISED IN COMMENTS HAVE BEEN RESOLVED**

In accordance with the Commission's June 8, 2022 Entry in this proceeding, Vectren Energy Delivery of Ohio, Inc. d/b/a CenterPoint Energy Ohio (CEOH or the Company) hereby files its statement informing the Commission whether issues raised in the comments have been resolved.

Staff filed Comments on July 7, 2022, which recommended approval of CEOH's Application to adjust its Distribution Replacement Rider (DRR) charges, and agreed with the total resulting revenue requirement of \$38,390,529 which was supported in the Company's Application.

Given the resolution of all issues raised by parties' comments in this proceeding, a hearing in this cause is unnecessary. Entry ¶ 7(d) (June 8, 2022). *See e.g.*, Case No. 21-0491-GA-RDR. Therefore, CEOH respectfully requests that the Commission approve its Application and the DRR charges set herein.
