**YELLOW WOOD SOLAR ENERGY LLC 'S  
RESPONSE TO THE SIXTH DATA REQUEST  
FROM THE STAFF OF THE OHIO POWER SITING BOARD**

On February 24, 2021, as supplemented, Yellow Wood Solar Energy LLC (“Applicant”) filed an application (“Application”) with the Ohio Power Siting Board (“OPSB”) proposing to construct a solar-powered electric generation facility in Clinton County, Ohio (“Project”).

On July 14, 2022, the Staff of the OPSB (“OPSB Staff”) provided the Applicant with OPSB Staff’s Sixth Data Request. Now comes the Applicant providing the following response to the Sixth Data Request from the OPSB Staff.

**Setbacks**

**1. Please verify the setbacks that will be used for the Project.**

**Response:** The Applicant commits that it will implement the following minimum setbacks from the Project’s solar modules into the facility’s final design: at least 150 feet from nonparticipating parcel boundaries; at least 300 feet from nonparticipating residences existing as of the filing of the Application; and at least 150 feet from the edge of pavement of any state, county, or township road within or adjacent to the Project Area. To the extent this commitment contradicts any other statements in the Application, this commitment replaces and supersedes such statements.
