In addition to electric and natural gas energy procurement services, Statistical Energy LLC also provides our clients with demand response, peak shaving, solar, battery storage, regulated tariff reviews and energy bill auditing services. We are currently licensed for electric and gas brokerage services in Ohio, Pennsylvania, Virginia, and New Jersey.

Application Experience and Plan Description: Mr. Risk, CFO & Founding Partner for Statistical Energy LLC, has been in the energy business for over 20 years and plans to utilize those relationships and contacts formed over the years to grow the commercial and industrial electric brokerage business for Statistical Energy LLC. Likewise, Mr. Jackson and Mr. Cantlie also have business relationships which they plan to utilize in growing our business. Today, Statistical Energy LLC has obtained contracts with clients which currently equate to 3,500,000 Dekatherms (annually) of natural gas and 550 million kWh of electric now being managed, and we plan to continue to leverage our relationships for the benefit of Statistical Energy LLC. Statistical Energy utilizes subcontractors to provide back-office, pricing and utility bill audit support as well as many other functions including demand response, peak shaving and other energy related services. As a broker, the energy suppliers provide the energy supply agreements which are signed by the client and also provide the billing to the clients, either directly or through the local distribution company. We currently have brokerage agreements with suppliers including but not limited to ENGIE, Constellation, Energy Harbor, GEXA/Nextera, DirectEnergy/Centrica/NRG, Dynegy/Vistra, Hudson, and Summer Energy. As a broker, the energy suppliers (typically not the client) are the ones who will pay Statistical Energy LLC on behalf of the clients. As a broker, Statistical Energy's job is to be an advocate for our clients with the utilities and energy companies. As a small organization, it is easy for clients to contact Mr. Risk, Mr. Jackson and Mr. Cantlie via the contact information provided elsewhere in this document. Mr. Risk, Mr. Jackson and Mr. Cantlie are always easy to reach and are willing to be compliant with the rules identified in Section 4929.22 of the Ohio Revised Code (contained in Chapter 4901:1-29 of the Ohio Administrative Code).

We help our clients find the best supplier for their unique needs. The licensed CRNGS suppliers we currently work with include:

In the following ranked order, 1. Constellation, 2. DirectEnergy and 3. ENGIE are our customer's three largest CRNGS Suppliers for natural gas commodities in deregulated States.

Statistical Energy, LLC has Master Broker Agreements in place with the preceding list of CRNGS. These Master Broker Agreements establish Statistical Energy, LLC as an independent contractor and outline the relationship between the CRNGS and Statistical Energy, LLC. From 2010 to 2016, Mr. Jackson was a Major Accounts Manager at a competing energy Brokerage Firm based in Columbus, Ohio where he managed a team of 30 to 40 energy professionals who brokered electric and natural gas and sold other energy solutions including demand response and peak shaving. In addition to his management responsibilities, Mr. Jackson also produced and managed his own book of energy brokerage accounts and he was one of the top 3 revenue producers at this energy brokerage firm. Mr. Jackson was often asked by his fellow energy professionals at this energy brokerage firm to utilize his energy technical expertise to help source and service larger and more complex energy clients and prospects. From 2007 to 2010, he was the N. American Energy Manager at Sanimax, where he managed a \$50 million energy portfolio for Sanimax's North American biodiesel manufacturing locations. From 2004 to 2007, he was a Senior Energy Analysis at National Water & Power, which provided managed energy solutions for their multi-family apartment clients. From 2000 to 2004, he was a National Account Manager at Cass Information Systems (NASDAQ: 'CASS'), which is a bank-based holding company which manages energy costs and provides energy and utility bill payment services, for ten to fifteen Fortune 100 companies which he was assigned to manage.

- Ronald Cantlie, President & Partner/Shareholder - Mr. Cantlie has been President, Partner & Shareholder of Statistical Energy, LLC since January of 2018. Statistical Energy has enjoyed double-digit growth and expansion since he joined our team. As President of Statistical Energy, LLC, Mr. Cantlie leads our sales and account management teams. Mr. Cantlie spearheaded the Spark Plug (energy brokerage CRM system) implementation project and he also currently manages that relationship for Statistical Energy, LLC. He is also currently a shareholder in WOR HQ LTD, which provides renewable energy solutions to companies in the USA. From 2010 to 2016, Mr. Cantlie was a Major Accounts Manager at a competing energy brokerage firm based in Columbus, Ohio, where he produced and managed his own book of

energy brokerage accounts. He was one of the top 3 sales revenue producers at this competing energy brokerage firm. Mr. Cantlie was often asked by his fellow energy professionals at this energy brokerage firm to utilize his energy technical expertise to help source and service larger and more complex energy clients and prospects.

Jim Risk, CFO & Partner/Shareholder - Statistical Energy, LLC's founder, Jim Risk, started working for Ohio Edison in 1997, so he has been involved with the energy business for over 20 years. As an employee of FirstEnergy Solutions (FES), Mr. Risk participated in the Pennsylvania electricity deregulation pilot back in 1998. Once the 1998 pilot was over, Mr. Risk also sold energy (electric & natural gas) for FirstEnergy Solutions in Pennsylvania as well as other States (i.e., Ohio, New Jersey, Pennsylvania, Maryland, and Delaware) which FES was licensed to sell energy in beginning in 1999. Mr. Risk was the first full-time sales employee ever employed at FES. Mr. Risk was also a founding business development executive for The E Group, which was the energy consulting business owned by FirstEnergy Solutions. While working for The E Group, Mr. Risk also helped re-engineer the State of Ohio natural gas aggregation program for Ohio's Department of Administrative Services ('DAS'). This DAS natural gas program, which was developed by Mr. Risk back in the early 2000's, is still in place today.

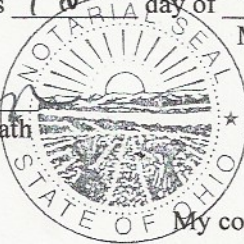
