**MOTION FOR EXTENSION OF TIME TO FILE RESPONSIVE PLEADING AND  
REQUEST FOR EXPEDITED TREATMENT OF  
NORTHEAST OHIO PUBLIC ENERGY COUNCIL**

In accordance with Ohio Administrative Code (“OAC”) 4901-1-12, 4901-1-13 and 4901-9-01, Northeast Ohio Public Energy Council (“NOPEC”) respectfully requests a two week extension of time to file a responsive pleading in this case until September 7, 2022. Good cause exists to grant this motion, which is detailed below.

On August 4, 2022, the Complainant, Carl Heinl, filed his complaint, and the Commission Docketing Division served a copy of the complaint upon NOPEC. NOPEC and Mr. Heinl have been actively discussing settlement and are seeking an agreeable resolution of the complaint. To allow settlement discussions to continue and avoid the need for unnecessary legal costs, NOPEC requests an extension of the due date for its responsive pleading until September 7, 2022.

NOPEC represents that Mr. Heinl does not object to this request. NOPEC further represents that this request is not being made for the purposes of delay and requests expedited treatment of this motion in accordance with OAC 4901-1-12(C).

For the foregoing reasons, NOPEC respectfully requests that the Commission grant its request for an extension of time to file a responsive pleading until September 7, 2022, on an expedited basis.
