Dear Ms. Troupe:

As required by paragraph 102 of the April 16, 2020 Opinion, Order and Certificate entered in this proceeding, please be advised that, through this letter, Nestlewood Solar I LLC ("Nestlewood") confirms the following:

- On July 7, 2022, Nestlewood submitted to Staff a landscape and lighting plan. Staff provided comments to same and, on August 22, 2022, Nestlewood submitted to Staff an updated landscape and lighting plan (copy attached) in compliance with Condition #12;
- 2) On March 28, 2022, Nestlewood submitted to Staff a final traffic plan, which was included in the transportation management plan (copy filed on OPSB case docket on March 29, 2022) in compliance with Condition #29;
- 3) On August 9, 2022, Nestlewood submitted to Staff one set of updated detailed engineering drawings (no change to project layout) in compliance with Condition #3. Additionally, per request from Staff, on August 18, 2022, Nestlewood submitted to Staff a KMZ file for the project layout;
- 4) On August 5, 2022, Nestlewood submitted to Staff a copy of the decommissioning report (not a condition, but submitted for information purposes only);

- 5) The attached updated (second mailing) pre-construction notice was mailed on August 9, 2022 to all persons or entities required by Conditions #10 and #15;
- In accordance with Condition #2, an updated pre-construction conference for tree-clearing and civil construction work was held with Staff on August 4, 2022;
- 7) In accordance with Condition #7, Nestlewood plans to: (i) start construction of the project on or around September 5, 2022, (ii) begin civil construction work in September 2022 through March 2023 and (iii) then proceed with tree clearing activities in the month of October 2022. Equipment installation is planned to begin between January 2023 and July 2023, with testing, commissioning and site restoration occurring in August, September, and October 2023; and
- 8) On August 15, 2022, Nestlewood submitted to Staff copies of the attached permits and authorizations in compliance with Condition #8.

This is an update to the information contained in the letter dated March 2, 2022 from Nestlewood Solar I. Nestlewood Solar I plans to start construction of an 80-megawatt project on or around September 5, 2022. We will begin Civil construction work in September 2022 through March 2023 and then proceed with tree clearing activities in the month of October 2022. Equipment installation is planned to begin between January 2023 and July 2023, with testing, commissioning and site restoration occurring in August, September, and October 2023.

General construction activities shall be limited to the hours of 7:00 a.m. to 7:00 p.m., or until dusk when sunset occurs after 7:00 p.m. Impact pile driving will occur between 9:00 a.m. and 7:00 p.m. However, construction activities that do not involve noise increases above ambient levels at nonparticipating residences are permitted outside of daylight hours when necessary.

#### NESTLEWOOD SOLAR COMPLAINT RESOLUTION PROGRAM

## 1. INTRODUCTION

Nestlewood Solar I LLC (Nestlewood Solar) has developed a complaint resolution program for implementation during the construction and operation of the Project to provide an effective process for identification and resolution of concerns voiced by members of the community.

Nestlewood Solar is committed to complying with requirements established through the Ohio Power Siting Board and other regulatory processes, and to establishing an accessible process for community members to voice concerns and for those concerns to be addressed as quickly and effectively as possible. Maintaining detailed records of all complaints and resulting actions is an important aspect of the complaint resolution program.

Nestlewood Solar's policy is to take all reasonable necessary actions to rectify legitimate interference or disturbances that are a direct result of the Project.

#### 2. COMPLAINT RESOLUTION PROCEDURE

#### 2.1 Nestlewood Solar Contacts

Nestlewood Solar will establish a toll-free telephone number and will provide that number to the county commissioners, township trustees, emergency responders, schools, and public libraries within the Project Area; that number will also be posted on the Project website. To register a complaint, individuals may either call the telephone number and leave a message or go to the project's local construction office during regular business hours. Messages will be checked daily, Monday thru Friday and initial follow up will occur within two business days. Any emergency situations should be addressed with the appropriate local authorities or by calling 911.

#### 2.2 Notification

In addition to providing the contact information and procedure to the officials and public locations noted above, Nestlewood Solar will maintain a Project contact list for area residents and will provide notification to residences located within 1 mile of the perimeter of the project site that construction or another major site activity is about to commence.

## 2.3 Complaint Documentation and Follow-Up

Nestlewood Solar will keep a logbook to register every complaint received. The logbook will include pertinent information about the person making the complaint, the issues surrounding the complaint, and the date the complaint was received; the complaint resolution form is attached.

The logbook will also document Nestlewood Solar's recommended resolution, the date agreement was reached on a proposed resolution, and the date when the proposed resolution was implemented. Nestlewood Solar personnel will generate a quarterly report based on the information recorded in the log book about the nature and resolution of all complaints received in that quarter, and submit the report to the OPSB on January 31, April 30, July 31, and October 31 of each calendar year or portion thereof during construction.

Individuals who register a complaint with Nestlewood Solar will receive correspondence from Nestlewood Solar no later than 2 business days after registering the complaint. The intent of the initial correspondence is to gather more information to better understand the complaint. Within 30 days of the complaint being logged, Nestlewood Solar will initiate reasonable action to resolve any legitimate interference or disturbance that is a direct result of the Project.

If Nestlewood Solar and the complaining individual cannot agree to a resolution, Nestlewood Solar will provide a summary of the complaint and proposed resolution to the complaining individual so the complaint can be brought to the OPSB.

We have received your recent correspondence requesting information about the subject proposal. There are no federal wilderness areas, wildlife refuges or designated critical habitat within the vicinity of the project area. The following comments and recommendations will assist you in fulfilling the requirements for consultation under section 7 of the Endangered Species Act of 1973, as amended (ESA).

The U.S. Fish and Wildlife Service (Service) recommends that proposed developments avoid and minimize water quality impacts and impacts to high quality fish and wildlife habitat (e.g., forests, streams, wetlands). Additionally, natural buffers around streams and wetlands should be preserved to enhance beneficial functions. If streams or wetlands will be impacted, the Corps of Engineers should be contacted to determine whether a Clean Water Act section 404 permit is required. Best management practices should be used to minimize erosion, especially on slopes. All disturbed areas should be mulched and revegetated with native plant species. Prevention of non-native, invasive plant establishment is critical in maintaining high quality habitats.

FEDERALLY LISTED SPECIES COMMENTS: All projects in the State of Ohio lie within the range of the federally endangered Indiana bat (Myotis sodalis) and the federally threatened northern long-eared bat (Myotis septentrionalis). In Ohio, presence of the Indiana bat and northern long-eared bat is assumed wherever suitable habitat occurs unless a presence/absence survey has been performed to document absence. Suitable summer habitat for Indiana bats and northern long-eared bats consists of a wide variety of forested/wooded habitats where they roost, forage, and travel and may also include some adjacent and interspersed non-forested habitats such as emergent wetlands and adjacent edges of agricultural fields, old fields and pastures. This includes forests and woodlots containing potential roosts (i.e., live trees and/or snags ≥3 inches diameter at breast height (dbh) that have any exfoliating bark, cracks, crevices, hollows and/or cavities), as well as linear features such as fencerows, riparian forests, and other wooded corridors. These wooded areas may be dense or loose aggregates of trees with variable amounts of canopy closure. Individual trees may be considered suitable habitat when they exhibit the characteristics of a potential roost tree and are located within 1,000 feet (305 meters) of other

forested/wooded habitat. Northern long-eared bats have also been observed roosting in humanmade structures, such as buildings, barns, bridges, and bat houses; therefore, these structures should also be considered potential summer habitat. In the winter, Indiana bats and northern long-eared bats hibernate in caves and abandoned mines.

The proposed project is in the vicinity of one or more confirmed records of Indiana bats and is in very close proximity to a known Indiana bat maternity roost tree. Therefore, we strongly recommend additional coordination with my office if any tree clearing will be necessary for the proposed project.

If there is a federal nexus for the project (e.g., federal funding provided, federal permits required to construct), no portion of the project should be initiated until consultation under section 7 of the ESA, between the Service and the federal action agency, is completed. We recommend that the federal action agency submit a determination of effects to this office, relative to the Indiana bat and northern long-eared bat, for our review and concurrence.

Due to the project type, size, and location, we do not anticipate adverse effects to any other federally endangered, threatened, proposed, or candidate species. Should the project design change, or during the term of this action, additional information on listed or proposed species or their critical habitat become available, or if new information reveals effects of the action that were not previously considered, consultation with the Service should be initiated to assess any potential impacts.

These comments have been prepared under the authority of the Fish and Wildlife Coordination Act (48 Stat. 401, as amended; 16 U.S.C. 661 et seq.), the ESA, and are consistent with the intent of the National Environmental Policy Act of 1969 and the Service's Mitigation Policy. This letter provides technical assistance only and does not serve as a completed section 7 consultation document. We recommend that the project be coordinated with the Ohio Department of Natural Resources due to the potential for the project to affect state listed species and/or state lands. Re: 18-970; Threatened and Endangered Species Review Information Request, Nestlewood Solar

**Project:** The proposed project involves developing and operation of the Nestlewood Solar 80-megawatt photovoltaic solar facility.

Location: The proposed project is located in Tate Township, Clermont County, Ohio.

The Ohio Department of Natural Resources (ODNR) has completed a review of the above referenced project. These comments were generated by an inter-disciplinary review within the Department. These comments have been prepared under the authority of the Fish and Wildlife Coordination Act (48 Stat. 401, as amended; 16 U.S.C. 661 et seq.), the National Environmental Policy Act, the Coastal Zone Management Act, Ohio Revised Code and other applicable laws and regulations. These comments are also based on ODNR's experience as the state natural resource management agency and do not supersede or replace the regulatory authority of any local, state or federal agency nor relieve the applicant of the obligation to comply with any local, state or federal laws or regulations.

**Natural Heritage Database:** A review of the Natural Heritage Database has the following record at or within a one-mile radius of the project area:

Kirtland's snake (Clonophis kirtlandii), State threatened, federal species of concern

The review was performed on the project area you specified in your request as well as an additional one-mile radius. Records searched date from 1980. This information is provided to inform you of features present within your project area and vicinity. Additional comments on some of the features may be found in pertinent sections below.

Please note that Ohio has not been completely surveyed and we rely on receiving information from many sources. Therefore, a lack of records for any particular area is not a statement that rare species or unique features are absent from that area. Although all types of plant communities have been surveyed, we only maintain records on the highest quality areas.

Fish and Wildlife: The Division of Wildlife (DOW) has the following comments.

The DOW recommends that impacts to wetlands and other water resources be avoided and minimized to the fullest extent possible, and that best management practices be utilized to minimize erosion and sedimentation.

The project is within the vicinity of records for the Indiana bat (Myotis sodalis), a state endangered and federally endangered species. Presence of the Indiana bat has been established in the area, and therefore additional summer surveys would not constitute presence/absence in the area. The following species of trees have relatively high value as potential Indiana bat roost trees to include: shagbark hickory (Carva ovata), shellbark hickory (Carya laciniosa), bitternut hickory (Carya cordiformis), black ash (Fraxinus nigra), green ash (Fraxinus pennsylvanica), white ash (Fraxinus americana), shingle oak (Quercus imbricaria), northern red oak (Ouercus rubra), slippery elm (Ulmus rubra), American elm (Ulmus americana), eastern cottonwood (Populus deltoides), silver maple (Acer saccharinum), sassafras (Sassafras albidum), post oak (Quercus stellata), and white oak (Quercus alba). Indiana bat roost trees consists of trees that include dead and dying trees with exfoliating bark, crevices, or cavities in upland areas or riparian corridors and living trees with exfoliating bark, cavities, or hollow areas formed from broken branches or tops. However, Indiana bats are also dependent on the forest structure surrounding roost trees. If suitable habitat occurs within the project area, the DOW recommends trees be conserved. If suitable habitat occurs within the project area and trees must be cut, the DOW recommends cutting occur between October 1 and March 31. If no tree removal is proposed, this project is not likely to impact this species.

The project is within the range of the rayed bean (*Villosa fabalis*), a state endangered and federally endangered mussel, the sheepnose (*Plethobasus cyphyus*), a state endangered and federally endangered mussel, the fanshell (*Cyprogenia stegaria*), a state endangered and federally endangered mussel, the pink mucket (*Lampsilis orbiculata*), a state endangered and federally endangered mussel, the snuffbox (*Epioblasma triquetra*), a state endangered and federally endangered mussel, the washboard (*Megalonaias nervosa*), a state endangered mussel, the ebonyshell (*Fusconaia ebena*), a state endangered mussel, the butterfly (*Ellipsaria lineolata*), a state endangered mussel, the elephant-ear (*Elliptio crassidens crassidens*), a state endangered mussel, the little spectaclecase (*Villosa lienosa*), a state endangered mussel, the monkey face (*Quadrula metanevra*), a state endangered mussel, the wartyback (*Quadrula nodulata*), a state endangered mussel, the threehorn wartyback (*Obliquaria reflexa*), a state threatened mussel, and the fawnsfoot (*Truncilla donaciformis*), a state threatened mussel.

This project must not have an impact on freshwater native mussels at the project site. This applies to both listed and non-listed species. Per the Ohio Mussel Survey Protocol (2018), all Group 2, 3, and 4 streams (Appendix A) require a mussel survey. Per the Ohio Mussel Survey Protocol, Group 1 streams (Appendix A) and unlisted streams with a watershed of 10 square miles or larger above the point of impact should be assessed using the Reconnaissance Survey for Unionid Mussels (Appendix B) to determine if mussels are present. Mussel surveys may be recommended for these streams as well. This is further explained within the Ohio Mussel Survey Protocol. Therefore, if in-water work is planned in any stream that meets any of the above criteria, the DOW recommends the applicant provide information to indicate no mussel impacts will occur. If this is not possible, the DOW recommends a professional malacologist conduct a mussel survey in the project area. If mussels that cannot be avoided are found in the project area, as a last resort, the DOW recommends a professional malacologist collect and relocate the mussels to suitable and similar habitat upstream of the project site. Mussel surveys and any subsequent mussel relocation should be done in accordance with the Ohio Mussel Survey Protocol. The Ohio Mussel Survey Protocol (2018) can be found at:

The project is within the range of the shortnose gar (Lepisosteus platostomus), a state endangered fish, the northern madtom (Noturus stigmosus), a state endangered fish, the shovelnose sturgeon (Scaphirhynchus platorynchus), a state endangered fish, the goldeye (Hiodon alosoides), a state endangered fish, the mountain madtom (Noturus eleutherus), a state threatened fish, the paddlefish (Polyodon spathula) a state threatened fish, the river darter (Percina shumardi), a state threatened fish, the bigeye shiner (Notropis boops), a state threatened fish, and the channel darter (Percina copelandi) a state threatened fish. The DOW recommends no in-water work in perennial streams from April 15 to June 30 to reduce impacts to indigenous aquatic species and their habitat. If no in-water work is proposed in a perennial stream, this project is not likely to impact these species.

The project is within the range of the Kirtland's snake (*Clonophis kirtlandii*), a state threatened species. This secretive species prefers wet fields and meadows. Habitat for this species may exist within the project area. The DOW recommends that a habitat suitability survey be conducted by an approved herpetologist to determine if suitable habitat is present within the project area. If suitable habitat is determined to be present, the DOW recommends that a presence/absence survey be conducted by the approved herpetologist. Approved herpetologist prepared survey reports can be submitted to Nathan Reardon, DOW Compliance Coordinator at Nathan.reardon@dnr.state.oh.us. Once project parcels are finalized, the DOW can rereview, and determine if this recommendation can be removed.

The project is within the range of the northern harrier (*Circus cyaneus*), a state endangered bird. This is a common migrant and winter species. Nesters are much rarer, although they occasionally breed in large marshes and grasslands. Harriers often nest in loose colonies. The female builds a nest out of sticks on the ground, often on top of a mound. Harriers hunt over grasslands. If this type of habitat will be impacted, construction should be avoided in this habitat during the species' nesting period of May 15 to August 1. If this habitat will not be impacted, this project is not likely to impact this species.

Due to the potential of impacts to federally listed species, as well as to state listed species, we recommend that this project be coordinated with the US Fish & Wildlife Service.

Water Resources: The Division of Water Resources has the following comments.

This letter is in response to the correspondence received July 17, 2020 regarding the proposed Nestlewood Solar Project, Tate Township, Clermont County and Clark Township, Brown County, Ohio. We appreciate the opportunity to comment on this project. The comments of the Ohio State Historic Preservation Office (SHPO) are made pursuant to Section 149.53 of the Ohio Revised Code and the Ohio Power Siting Board rules for siting this project (OAC 4906-4). The comments of the Ohio SHPO are also submitted in accordance with the provisions of Section 106 of the National Historic Preservation Act of 1966, as amended (54 U.S.C. 306108 [36 CFR 800]).

The following comments pertain to the revised *Phase I Archaeological Investigations for the 246.9 ha (610 ac) Nestlewood Solar Project in Tate Township, Clermont County and Clark Township, Brown County, Ohio* by Ryan J. Weller (Weller & Associates, Inc., 2020).

A literature review, visual inspection, surface collection, and shovel test unit excavation was completed as part of the investigations. No previously identified archaeological sites are located within the project footprint. Eight (8) new archaeological sites were identified during survey, Ohio Archaeological Inventory (OAI) #33CT0736-33CT0741 and 33BR0228-33BR0229. None of the sites are recommended eligible for listing in the National Register of Historic Places (NRHP). Our office agrees with this recommendation and no further archaeological survey is necessary.

The History/Architecture Survey was previously coordinated with our office, and a concurrence letter on the results of that survey was issued June 14, 2020. Therefore, it was determined that the Nestlewood Solar Project will not affect historic properties. No further coordination with this office is necessary, unless the project changes or unless new or additional historic properties are discovered during implementation of this project. This letter is in response to correspondence received on May 15, 2020. The comments of the Ohio State Historic Preservation Office (SHPO) are made pursuant to Section 106 of the National Historic Preservation Act of 1966, as amended, and the associated regulations at 36 CFR Part 800.

Nestlewood Solar I LLC proposes to construct an 80 megawatt solar farm on 610 acres in the vicinity of Sodom Road, Bethel Maple Road, Antioch Road, Leonard Road, Oak Corner Road, Bethel Maple Road, Vandament Road, and Liming Lake Road. You have requested the comments of SHPO regarding the effects of the proposed solar farm on historic properties.

As part of the submitted information, the *Phase I History/Architecture Survey for the Nestlewood Solar Project in portions of Tate Township, Clermont County and Clark Township, Brown County, Ohio* authored by Kramb Consulting, LLC recommended the finding of no historic properties affected.
