I. SUMMARY

{¶ 1} The Commission finds that Certificate No. 16-SPV-OH-GATS-0821 should be revoked, and this case should be dismissed and closed of record.

II. DISCUSSION

- {¶ 2} On May 25, 2016, Sol Systems, LLC, on behalf of Godman Guild (Applicant), filed an application for certification of a renewable energy resource facility located at 303 East Sixth Ave Columbus, Ohio 43201 (Facility). According to the application, the Facility is a rooftop solar photovoltaic electricity generator.
- {¶ 3} On December 21, 2016, the application was approved by the Commission, and the Facility was issued Certificate No. 16-SPV-OH-GATS-0821 on December 29, 2016.
- {¶ 4} On March 4, 2022, Applicant filed a letter requesting that the Commission revoke Certificate No. 16-SPV-OH-GATS-0821, as it is a duplicate certificate. A certificate was previously issued for the Facility in Case No. 13-408-EL-REN on July 14, 2013 (Certificate No. 13-SPV-OH-GATS-0443).
- {¶ 5} The Commission finds Applicant's request to revoke Certificate No. 16-SPV-OH-GATS-0821 is reasonable and should be granted.
