Entered in the Journal on August 25, 2022

{¶ 1} Staff served a notice of preliminary determination upon Victor Kutsar (Respondent) in accordance with Ohio Adm.Code 4901:2-7-12, alleging a violation of the Commission's transportation regulations.

{¶ 2} On June 6, 2022, Respondent requested an administrative hearing in accordance with Ohio Adm.Code 4901:2-7-13.

{¶ 3} On July 21, 2022, the attorney examiner scheduled a prehearing conference to be held on August 26, 2022.

{¶ 4} Prior to the prehearing conference, the attorney examiner received correspondence dated August 15, 2022, from Respondent, through counsel, that (1) advised that Respondent had retained counsel, and (2) requested that the prehearing conference be continued.

{¶ 5} As set forth in Ohio Adm.Code 4901:2-7-16(B), unless otherwise ordered by the Commission or agreed by the parties, a prehearing conference in a civil forfeiture case shall be scheduled upon the filing of a request for administrative hearing.

{¶ 6} The attorney examiner finds that the telephonic prehearing conference should be rescheduled to take place on September 9, 2022, at 2:00 p.m., ET. At that time, the attorney examiner will attempt to contact counsel for Respondent by telephone.

{¶ 7} Additionally, counsel should be advised that future communications and requests must be filed in the docket. Documents can be filed via U.S. mail by sending to: PUCO docketing division, 11th Floor, 180 East Broad Street, Columbus, Ohio 43215.

Documents can also be e-filed at dis.puc.state.oh.us or filed via fax by faxing the document to 614-466-0313. Case No. 22-570-TR-CVF should appear on all filed documents. Additionally, the docketing division can be reached at 614-466-4095 to answer questions related to filing documents.

{¶ 8} It is, therefore,

{¶ 9} ORDERED, That a prehearing conference in this case be rescheduled in accordance with Paragraph 6. It is, further,

{¶ 10} ORDERED, That a copy of this Entry be served upon all parties of record.
