#### Dear Customer,

This is an update to the closing of Gasearch, LLC. as a natural gas supplier. Hopefully this information will help to give you clear instructions on how to move forward with your Choice natural gas accounts.

Gasearch has submitted requests to Dominion Energy Ohio for a change in your commodity service. Your service will not be interrupted as a result of this request.

Given Dominion Energy Ohio's timeline for Choice enrollment files and depending on the timing of your billing cycle, your account may bill one more time in November, with Gasearch as your current supplier. Your December billing will then move to your new supplier or to be served under DEO's default service. Please take note that if your account remains with Gasearch your November bill may be invoiced at the current market rate. We urge you to sign up with a new supplier or new supply option as soon as possible to help mitigate your natural gas costs moving forward.

If you do not select a supplier, you will still receive natural gas service from Dominion Energy Ohio, your local distribution utility. For residential customers and non-residential customers consuming 200 MCF or less per year, you will default to Dominion's Standard Choice Offer (SCO), which is a monthly variable rate based on the NYMEX and is posted at EnergyChoice.ohio.gov. For nonresidential customers consuming over 200 MCF/year, you will default to Dominion's monthly retail rate (MRR), which is also posted on the Energy Choice website, if you do not select another supply option.

We apologize for the confusion the first email has caused. The email was the result of some confusion on the part of Gasearch. Please know that the decision to close was not an easy decision for Gasearch.

It has been our extreme pleasure to have served the community and all of our customers for the past 21 years.
