COMMENTS OF AES OHIO

Pursuant to the August 22, 2022 Entry in this proceeding, The Dayton Power and Light Company d/b/a AES Ohio (“AES Ohio” or the “Company”) files these comments in support of its May 11, 2022 Amended Application to recover certain storm-restoration costs for three major-event storms that occurred in 2020 and related carrying charges.

On June 30, 2022, Staff issued a Recommendation regarding the Amended Application. Staff examined the Company’s request for consistency with previous storm rider cases to ensure that proper accounting and regulatory treatment were applied. Staff Recommendation, p. 1. “The audit consisted of a review of the final statements for completeness, occurrence, presentation, valuation, allocation and accuracy.” *Id.*

As a result of that review, the Staff recommends approval an additional, adjusted revenue requirement of \$2,468,141, reflecting a \$31.51 reduction to reflect employee-purchased snacks and meals and a \$65,730 reduction in carrying costs as compared to the Amended Application. *Id.* at 2. The Staff states that its treatment of carrying costs is consistent with the May 18, 2022 Finding and Order in AES Ohio’s most recent storm rider proceeding, Case No. 21-92-EL-RDR. *Id.*

AES Ohio has reviewed the findings and recommendations in the Staff Recommendation and does not oppose them.
