Councilman AS Case moved the adoption of the following resolution:

Whereas, on November 8, 2011, the residents of the Village of Lyons voted in favor of electric aggregation to improve purchasing leverage and offer reduced electrical generation rates to residential and small business consumers, and,

Whereas, the Fulton County Commissioners have offered their services to act on behalf of all Townships and Villages in Fulton County as the governmental aggregator, and,

Whereas, having one centralized aggregator will provide for the most expeditious manner to handle any issues arising in the process of electrical aggregation,

**THEREFORE, Be It Resolved,**

Section 1. The Village Council of the Village of Lyons hereby authorize the Fulton County Commissioners to act as the governmental agent for purchasing and aggregation of electric power for the residents of the Village of Lyons.

Section 2. This resolution shall be copied to the Fulton County Commissioners, 152 South Fulton St, Ste 270, Wauseon, OH 43567

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were so adopted in an open meeting of this Village, and that all formal actions, were in meetings open to the public, in compliance with all legal requirements.
