On 07/08/2022, a vehicle operated by RLPJ ENTERPRIZES INC, and driven by, PRATT, ROBERT L was inspected within the state of Ohio. As a result of discovery of the following violation(s) of the Commission's rules, Staff of the Commission timely notified ROBERT PRATT pursuant to rule 4901:2-7-07, Ohio Administrative Code (OAC), that it intended to assess a civil forfeiture against ROBERT PRATT in the following amount:
