Notice of Proposed Major Utility Facility

The Dayton Power and Light Company doing business as "AES Ohio" is proposing the construction of the AES Ohio Sidney – Franklin Honda 138kV Rebuild/Extension Project ("the Project"). AES Ohio is planning the partial rebuild of 5.3-miles of the existing 6628 Sidney – Amsterdam 69kV transmission line and the installation of the new 1.9-mile 13854 Sidney – Franklin 138kV transmission line. The new 13854 line will be constructed on a segment of the existing single circuit 6628 line. To support the new 13854 line, the existing single circuit transmission line pole structures of the existing 6628 line will need to be removed and replaced with double-circuit 69kV/138kV pole structures. The installation of the new 13854 Sidney – Franklin 138kV transmission line will begin at structure 246102, near the intersection of State Route 29 and Kuther Road, of the existing 6628 Sidney – Amsterdam 69kV transmission line and continue to the new Franklin Substation. The line rebuild with the addition of a 138kV circuit to the existing lines, and the new 138kV transmission line route will allow for the reliable supply of 138kV sources to the new Franklin substation. The proposed Project is needed to improve the resilience and reliability of the area power system, increase operational flexibility, and to meet the requirements of HDMast and the surrounding transmission network. The proposed Project is located in Franklin and Turtle Creek Townships, as well as the city of Sidney within Shelby County, Ohio. In accordance with Ohio Administrative Code (OAC) Rule 4906-06-05, the Project must be within the Ohio Power Siting Board (OPSB) requirements for a Letter of Notification (LON) Application.
