AEP Ohio Transmission Company, Inc. (the “Company”) filed an Application for a Certificate of Environmental Compatibility and Public Need for the Groves Road-Shannon 138 kV Transmission Line Project (the “Project”) on March 8, 2022. The Company now submits the following information to correct and supplement the sections of its Application indicated below:

4906-5-04 (B), Appendix 4-1, and 4906-5-08 (B)(3)(a)

In these sections of the Application, the Company initially incorrectly indicated that the acreage of tree clearing for the Alternate Route was approximately 2.8 acres. The correct acreage of tree clearing for the Alternate Route is approximately 6.5 acres.

In addition to tree clearing discrepancies, the Company also incorrectly indicated land use impact for the Alternate Route in Table 8-4 of Section 4906-5-08 (B)(3)(a). Please see below for the corrected Table 8-4.
