MEMORANDUM IN SUPPORT

On September 9, 2021, Complainants Frederick and Danielle Sallee commenced this proceeding against AES Ohio relating to billing issues associated with service to 401 S. Troy Street, Bellefontaine, Ohio. AES Ohio filed an answer on December 9, 2021 and requested a mediation pursuant to Ohio Adm.Code 4901-9-01(G).

The Attorney Examiner subsequently scheduled a telephonic settlement conference for May 17, 2022. Apr. 5, 2022 Entry. AES Ohio and Mr. Sallee attended the settlement conference. Based on the parties' discussion during that conference, AES worked toward resolving the dispute in the weeks that followed and believes that the issues raised in the Complaint have largely been resolved; however, a written settlement has not been reached. Despite repeated requests by AES Ohio, Complainants have not identified what remains at issue in this case.
