Hello,

Today, we had a train traverse all movements through the crossing on normal and standby and the stop/flag bulletin has been cancelled. The crossing is officially in-service 8-1-2022 with construction complete by Progress Rail on 7-24-2022.

A few items:

- We used 2 first-section aluminum gates from CFE stock since NEG gave Progress Rail only mid-section gates
- Redrawn plans for the approach signal and the crossover site were not placed in each respective location, I didn't see them in the crossing bungalow either
- The long cable temperature probe that was sent to the hotel ended up being "return-to-sender" by the hotel mistakenly before I was able to pick up
- Switch insulation items or any other material can be sent to Lima office 1125 North Cole Street, Lima,
 OH 45805 Signal Maintainer Don Metzger
- When we are able, one insulated joint that we couldn't get the end post or 2 bolts installed will be finished by CFE. We have the end post and bolts.

Progress Rail Foreman Paul Crosby and crew did a great job and made sure every part of the construction was installed accurately. Thanks, ~EAO

The ORDC has provided construction authorization. You may proceed with ordering of materials and utility/power work such as off site house wiring and any power/meter service coordination with the power company. However, construction cannot be scheduled and no onsite signal work can be done until the PUCO issues their ORDER. This typically comes 1 to 2 months after construction authorization.
