





Astral Energy LLC was formed in February 2009, and has been serving the New Jersey natural gas market (PSE&G) since 2011, the electric market (ACE, JCP&L, PSE&G, and Rockland) since 2012; the New York electric and gas market (ConEd, Central Hudson, Orange & Rockland, Rochester Gas & Electric, National Grid, and NY State Electric & Gas) since 2013; the Pennsylvania electric market (Duquesne, MetEd, PECO, PPL, Penelec, Penn Power, and West Penn Power) since 2015, the gas market (PECO, Peoples, and UGI) since 2016; the Ohio electric market (AEP, Dayton, Duke, OhioEd, and ToledoEd) since 2016, gas market (Duke) since 2017; Massachusetts electric (National Grid, EverSource and Unitil) market since 2017; and the Maryland electric (Baltimore G&E, PotomacEd, Delmarva Power, and Potomac Electric) market since 2018.
