This letter is in response to the correspondence received September 21, 2022 regarding the proposed Nottingham Station Project, Athens Township, Harrison County, Ohio. We appreciate the opportunity to comment on this project. The comments of the Ohio State Historic Preservation Office (SHPO) are made pursuant to Section 149.53 of the Ohio Revised Code and the Ohio Power Siting Board rules for siting this project (OAC 4906-5). The comments of the Ohio SHPO are also submitted in accordance with the provisions of Section 106 of the National Historic Preservation Act of 1966, as amended (54 U.S.C. 306108 [36 CFR 800]).

Our office was provided with a letter report titled *Addendum Cultural Resource Management Investigations/Review for the Nottingham Station Project in Athens Township, Harrison County, Ohio* (BPID R20119002) by Ryan Weller (Weller & Associates, Inc. 2022). This letter report determined the entirety of the addendum project area was previously investigated and/or disturbed and archaeological investigation would not be necessary. Our office agrees with this recommendation.

Two (2) additional documents were provided for this project, completed as due diligence surveys for AEP. Those documented include the *Phase I Cultural Resource Management Investigations for the 6.9 km (4.3 mi) Nottingham-Freebyrd Electric Line Project in Cadiz and Athens Township, Harrison County, Ohio* by Ryan Weller (Weller & Associates, Inc. 2015) and *Disturbance Letter for the Nottingham Switch Station and Nottingham-Freebyrd 138kV Line project in Harrison County, Ohio* by Ryan Weller (Weller & Associates, Inc. 2015). Our office appreciates having those documents for our files.

Based on the information provided, we continue to agree that the project as proposed will have no effect on historic properties. No further coordination with this office is necessary, unless the project changes or unless new or additional historic properties are discovered during implementation of this project.
