"I strongly oppose the proposed large increase in the fixed charges component for gas bills to residential customers. More and more unwarranted costs are being passed on to consumers who have no say in what these charges are for. Paying customers are saddled covering bills unpaid by customers who refuse to pay their bills. Columbia Gas should pursue outstanding accounts and shut off service to delinquent accounts and n stead of passing the unpaid balances to those who do pay and hiding them in the name of fixed costs.

Paying customers are not responsible for Columbias failure to collect unpaid balances from other accounts. Also the Government should stop forcing Columbia

gas to provide service to accounts past due. Stop enabling those who abuse their responsibilities to pay for services they receive."
