The Applicant's provision of service is targeted to business customers and will provide a competitive alternative to the public. It will promote, through competition, the efficient use of the telecommunications networks. Customers will benefit by having alternatives from which to choose and from general improvements in price, features and options that are generated by competitive pressures.

The Applicant's proposed services will provide multiple public benefits by increasing the efficiency of incumbent carriers by providing users of telecommunications services with greater reliability and by increasing the competitive choices available to users in the State.
