MOTION FOR CONFIDENTIAL TREATMENT

Eligo Energy OH, LLC ("Eligo") hereby requests the Public Utilities Commission of Ohio ("Commission") to enter an order pursuant to 4901-1-24 of the Ohio Administrative Code to protect certain confidential and proprietary data and information of Eligo that has been included with Eligo Certification Application for Natural Gas Suppliers. Specifically, Eligo requests that the Commission treat Exhibits C-2, C-3 and C-5 as confidential and proprietary.

Section 4901-1-24 of the Ohio Administrative Code exempts from public disclosure "trade secrets and commercial or financial information obtained from a person or business where the trade secrets or commercial or financial information are furnished under a claim that they are proprietary, privileged or confidential, and that disclosure of the trade secrets or commercial or financial information would cause competitive harm to the person or business, and only insofar as the claim directly applies to the records requested." The confidential financial information of Eligo clearly falls within this exception.

WHEREFORE, Eligo respectfully requests that the Commission enter an Order, without hearing, protecting the confidentiality of Eligo information in Eligo Certification Application for Natural Gas Suppliers, and that such information be kept under seal as "Confidential" and not be made a part of the public record, and not be published or posted on the websites of the Public Utilities Commission of Ohio.


