

On 04/22/2022, a vehicle operated by PARTNERS N PROGRESS INC, and driven by, REMBERT-SCROGGINS, TIMOTHY P was inspected within the state of Ohio. As a result of discovery of the following violation(s) of the Commission's rules, Staff of the Commission timely notified TIMOTHY P REMBERT-SCROGGINS pursuant to rule 4901:2-7-07, Ohio Administrative Code (OAC), that it intended to assess a civil forfeiture against TIMOTHY P REMBERT-SCROGGINS in the following amount:
