MEMORANDUM IN SUPPORT OF MOTION FOR CONTINUANCE OF THE EVIDENTIARY HEARING AND REQUEST FOR EXPEDITED RULING

By Entry dated June 16, 2022, the Commission adopted a procedural schedule setting dates for intervention, discovery, the filing of testimony, and the evidentiary hearing in the above-captioned case. On September 15, 2022, the Company filed an unopposed motion for continuance of the evidentiary hearing and request for expedited ruling. Since the Company had already began publishing notice of the evidentiary hearing date in newspapers of general circulation, the Company's unopposed motion asked the Commission to call the hearing, as scheduled, on September 27, 2022, and then immediately continue the hearing to November 9, 2022. On September 16, 2022, the Attorney Examiner issued an entry granting the unopposed motion and continued the evidentiary hearing to November 9, 2022. Since then, the parties have actively pursued and participated in all-party and individual settlement discussions.

Good cause exists to grant a continuance of the evidentiary hearing from November 9, 2022, to December 7, 2022. The parties have engaged in a number of productive settlement

discussions, which, if successful, could potentially dispense with the need for an evidentiary hearing in the above-captioned proceedings. In the interest of expediting a resolution to the disputed issues in this case, the parties require more time to further pursue those settlement negotiations.

WHEREFORE, the Company requests that the evidentiary hearing date currently scheduled for November 9, 2022, be rescheduled to begin on or about December 7, 2022. Granting this Motion for Continuance of the Evidentiary Hearing and Request for Expedited Ruling (Motion) will reasonably accommodate and allow the parties to further pursue settlement discussions. Prior to filing this Motion, the Company contacted counsel for all parties to this proceeding. The Company can certify that Duke Energy Ohio, Interstate Gas Supply, Inc., and the Retail Energy Supply Association support the filing of this Motion. Staff of the Public Utilities Commission of Ohio and Spire Marketing Inc. indicated that they neither support nor oppose the Motion. Finally, the Office of the Ohio Consumers' Counsel indicated that it expressly reserves its right to support, oppose, or not oppose the Motion.
