MEMORANDUM IN SUPPORT

Staff requests that the Commission keep both the Report of the Commission's Consultant Regarding AEP Ohio's November 2022 Standard Service Offer Auction and the Notification of Auction Results under AEP Ohio's CBP confidential and that they not be publicly released. This information identifies the details of various bids and parties making the bids in the November 1, 2022 AEP Ohio auction. This information is highly competitively sensitive.
